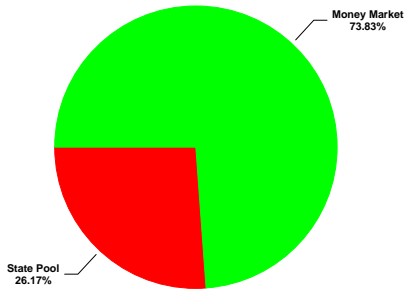

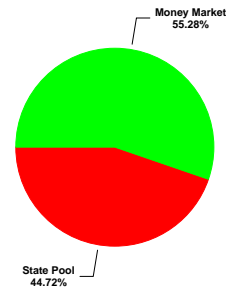

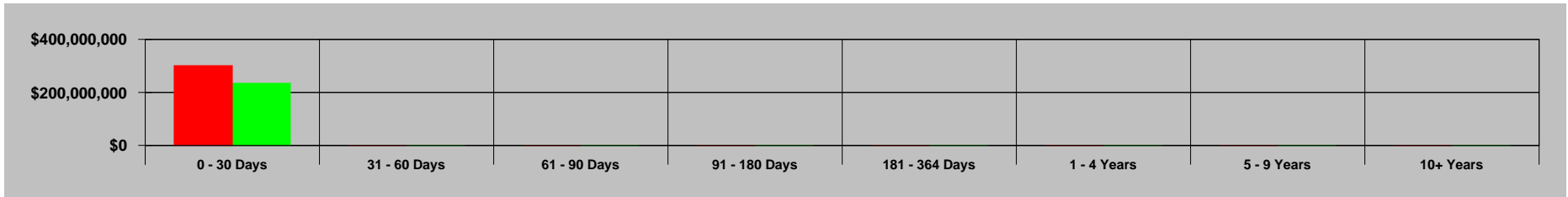
Portfolio Composition - 02/28/09



Portfolio Composition - 03/31/09

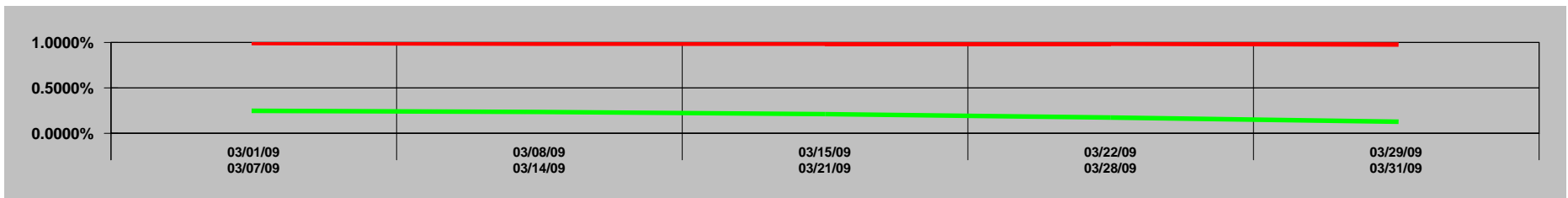


Maturity Aging - 02/28/09 vs 03/31/09

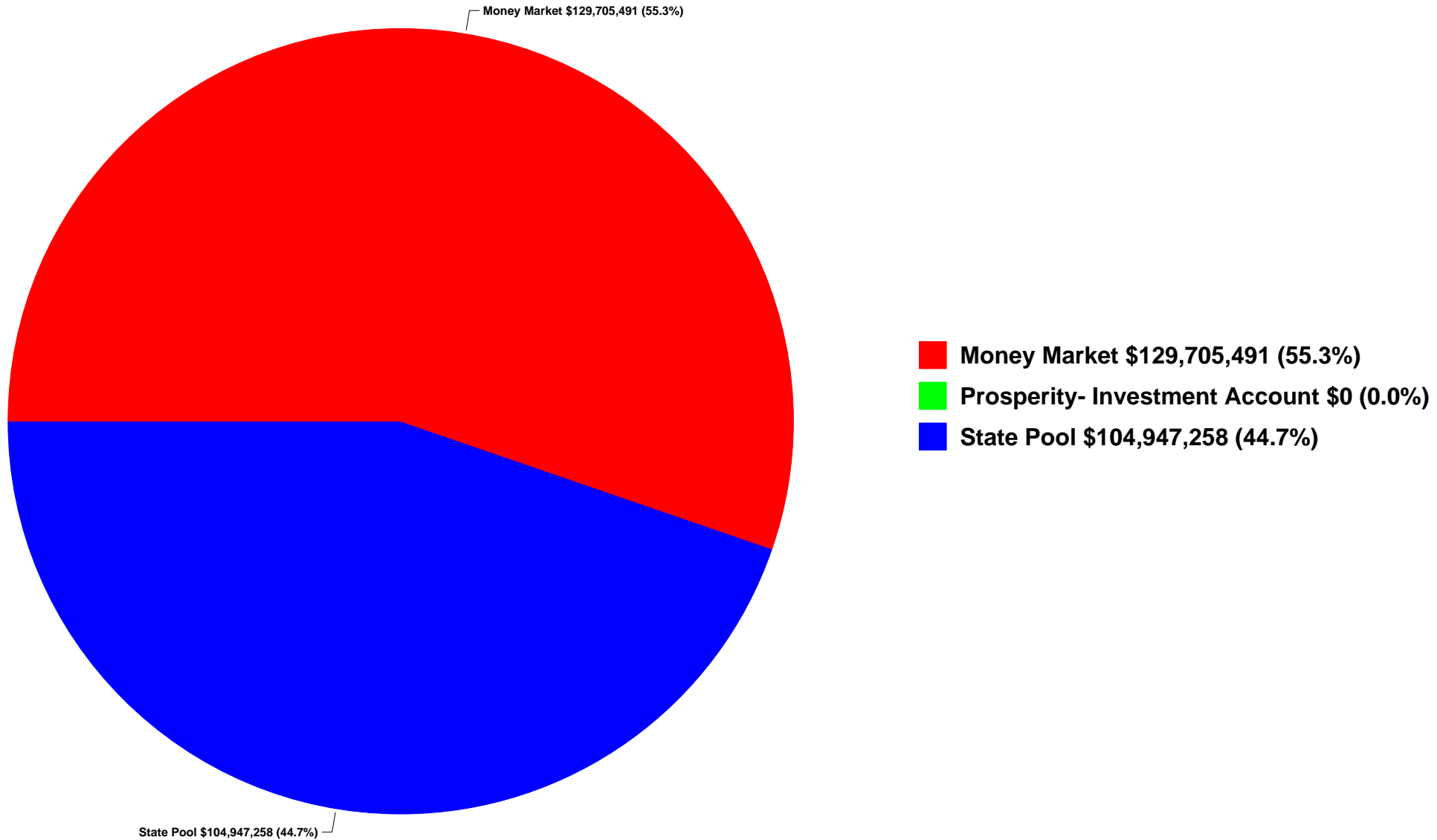

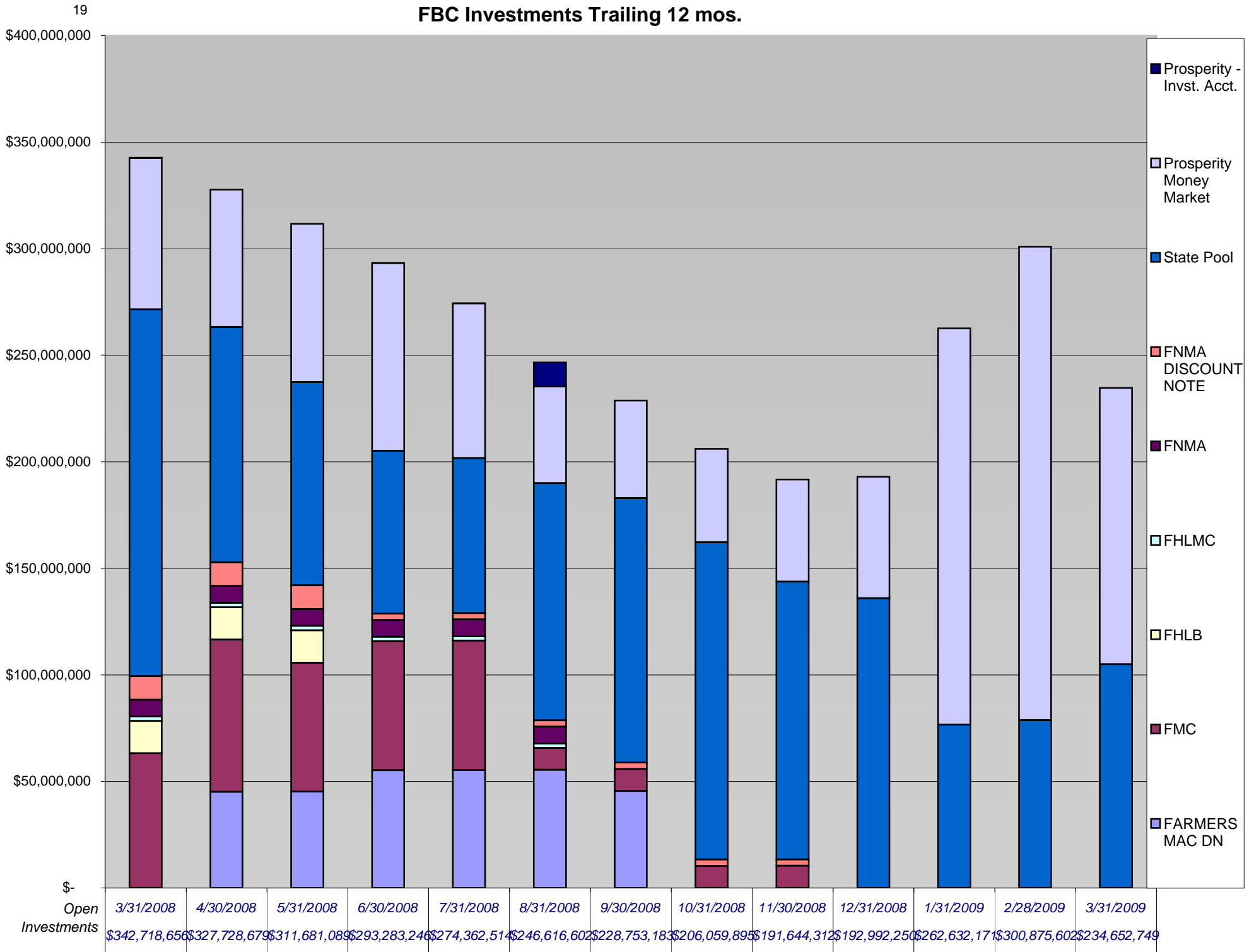

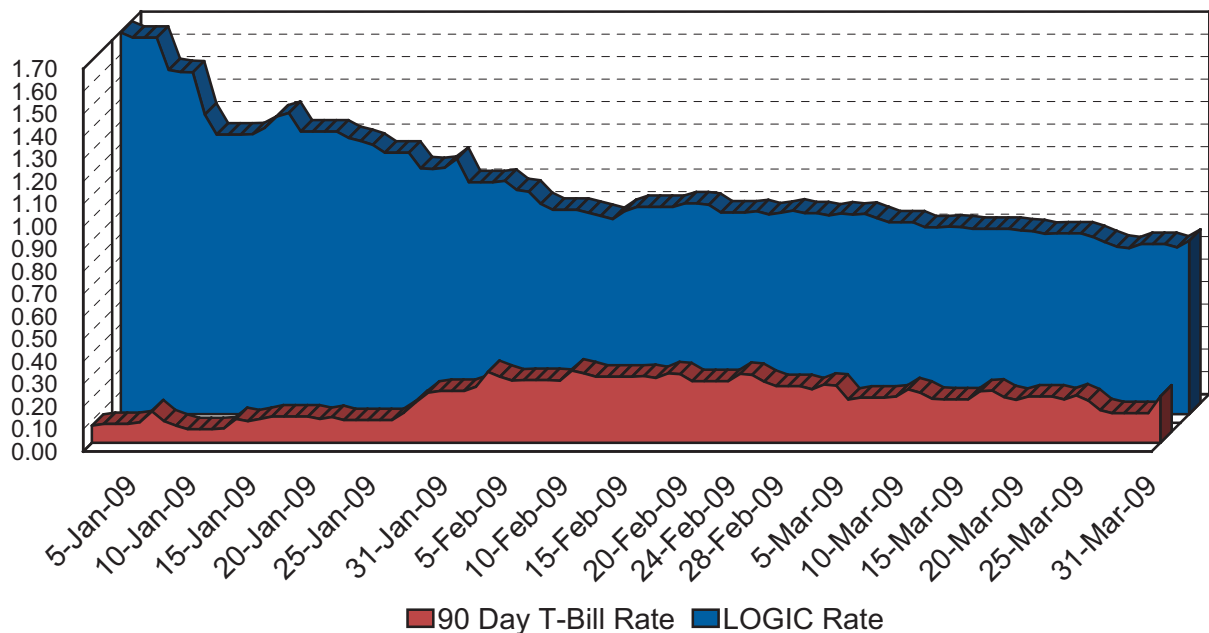
