UPON ARRIVAL I MET THE COMPLAINANT, CHAD DAY (OL 10481163) WHO STATED HE IS THE LIEUTENANT OF THE ORCHARD FIRE DEPARTMENT AND BETWEEN 06/24/09 AT ABOUT 1800 HOURS AND 07/01/09 AT ABOUT 0600, UNKNOWN PERSON(S) ENTERED THE FIRE TRUCK HE OPERATES AND REMOVED PROPERTY WITHOUT CONSENT. PROSECUTION IS DESIRED.

SCENE SUMMARY:

THE BUILDING LOCATED AT 38725 W. BOOTHILL IS A SINGLE STORY WITH WOOD TRIM RESIDENCE AND THE FRONT DOOR FACES NORTH.

ENTRY:

NO OBVIOUS SIGNS OF ENTRY

EXIT:

NO OBVIOUS SIGNS OF EXIT.

SCENE SEARCH:

I BEGAN MY CRIME SCENE INVESTIGATION BY OBSERVING A RED FIRE TRUCK BEARING TEXAS REGISTRATION 779-924 AND "ORCHARD FIRE RESCUE" ON BOTH SIDES OF THE ENGINE TO BE PARKED FACING THE ROADWAY ON THE DRIVEWAY ATTACHED TO 28725 W. BOOTHILL RD.

I DID NOT OBSERVE ANY FORCED ENTRY TO THE VEHICLE. 38725

I OBSERVED AN EMPTY SPACE IN THE CENTER CONSOLE OF THE PASSENGER COMPARTMENT WHERE CHAD DAY ADVISED WAS WHERE A BLACK SIREN/RADIO CONTROL BOX WAS LOCATED AND IS NOW MISSING. I ALSO OBSERVED A SMALL AREA ATTACHED TO THE RIGHT SIDE OF THE REMAINING FRAME OF THE CONTROL BOX AND NEXT TO THE DRIVER'S SEAT WHERE CHAD DAY ADVISED WAS WHERE A BLACK RADIO WAS LOCATED THAT IS NOW MISSING.

I WAS UNABLE TO OBTAIN THE RADIO NUMBER ATTACHED TO THE MISSING ITEMS. I ADVISED CHAD DAY TO CONTACT FORT BEND COUNTY SHERIFF'S OFFICE AS SOON AS HE GETS THIS INFORMATION.

I WAS ADVISED BY CHAD DAY THAT THE MISSING RADIO CONTAINS A TRACKING DEVICE WITHIN THE RADIO THAT CAN ALLOW THE ITEM TO BE TRACED WHEN SEARCHING BY THE SPECIFIC RADIO NUMBER. I WAS ALSO ADVISED BY CHAD DAY THAT ORCHARD FIRE DEPARTMENT RENTS THEIR MOBILE IN CAR RADIO FROM THE FORT BEND COUNTY SHERIFF'S OFFICE.

I CONTACTED THE FIRE MARSHALL, UNIT 4008, AND ADVISED HIM OF THE INCIDENT.

I DUSTED THE ENTIRE CONSOLE AREA FOR PRINTS BUT WAS UNABLE TO LOCATE ANY.

I TOOK SEVERAL PHOTOGRAPHS OF THE CRIME SCENE AND SUBMITTED THEM INTO THE EVIDENCE ROOM LOCATED AT THE FORT BEND COUNTY SHERIFF'S OFFICE ON 07/01/09.

OTHER:

CHAD DAY STATED THAT HIS CO-WORKER, JAY KING DROPPED THE FIRE TRUCK OFF AT HIS RESIDENCE ON 06/24/09 AT ABOUT 1800 HOURS. I SPOKE WITH JAY KING WHO STATED THAT HE OBSERVED THE CONTROL BOX AND THE RADIO TO BE IN THEIR ORIGINAL LOCATIONS UPON DROPPING OFF THE FIRE TRUCK.

CHAD DAY STATED THE FIRE TRUCK WAS LEFT UNLOCKED. CHAD DAY STATED HE RECALLS HAVING SEEN A BLUE NEWER MODEL CHEVROLET TRUCK OCCUPIED BY AN UNKNOWN NUMBER OR DESCRIPTION OF PERSON(S) TO BE PARKED NEAR THE RESIDENCE ON 06/26/09 DURING EVENING HOURS. CHAD DAY STATED HE OBSERVED THE BLUE TRUCK TO SPEED AWAY WHEN HE BEGAN WALKING TOWARD IT. CHAD DAY STATED HE DOES NOT RECALL HAVING EVER SEEN THAT TRUCK PRIOR TO THIS INCIDENT.
