
In the time of a county wide disaster, any and all cost associated with activating (based upon the recommendation of Fort Bend County Road Commissioner) the debris collection and disposal and debris monitoring contracts within a Joint Resolution Jurisdiction's limits, will be paid for by Fort Bend County (the applicant).

Therefore, it will be the responsibility of each Joint Resolution Jurisdiction to reimburse Fort Bend County for all non-reimbursable cost for these services within ten days from proper notice of amount due.


