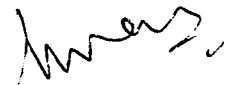

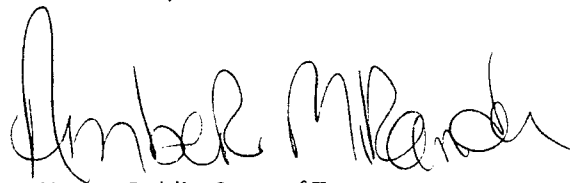
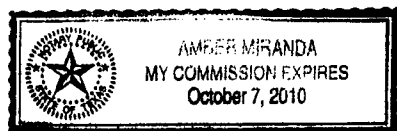

## Notice of Public Hearing on Tax Increase

The Fort Bend County Drainage will hold two public hearings on a proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by 28.54 percent (percentage by which proposed tax rate exceeds lower of rollback tax rate or effective tax rate calculated under Chapter 26, Tax Code). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted.

The first public hearing will be held on October 2, 2009 at 6:00 PM at Fort Bend County Commissioners Court, William B. Travis Bldg., 309 South Fourth Street, Richmond, Texas 77469.

The second public hearing will be held on October 6, 2009 at 1:00 PM at Fort Bend County Commissioners Court, William B. Travis Bldg., 309 South Fourth Street, Richmond, Texas 77469.

The average taxable value of a residence homestead in Fort Bend County Drainage last year was \$153,004. Based on last year's tax rate of \$0.01600 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$24.48.

The average taxable value of a residence homestead in Fort Bend County Drainage this year is \$156,873. If the governing body adopts the effective tax rate for this year of \$0.01615 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$25.33

If the governing body adopts the proposed tax rate of \$0.02076 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$32.57.
