

**AMENDMENT NO. 2 ("Amendment 2")
TO TECHSHARE RESOURCE SHARING ADDENDUM

The Parties hereby amend the TECHSHARE RESOURCE SHARING ADDENDUM ("Addendum") for the Common Integrated Justice System ("CIJS") Court Administration System that was approved by the County of Fort Bend, Texas ("Fort Bend County") and became effective on July 25, 2006 and executed by all parties by July 28, 2006.

- 1) The effective date of the Addendum is extended to September 30, 2010.
- 2) Attachment A of the Addendum is amended by replacing the "Anticipated Payments to Texas Conference of Urban Counties in Fiscal Year 2009" with the attached "Anticipated Payments to Texas Conference of Urban Counties in Fiscal Year 2010."
