

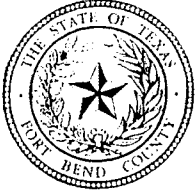

We have received an appraisal for the damage to Unit M-070 that was totaled in an accident on October 26, 2009. The appraised value of the vehicle is \$12,950.00. After the final subtraction of expenses against this claim (appraisal fee of \$ 91.00 and the salvage value of \$2,000.00) the balance that will be available for use will be \$10,859.00. Whenever the time comes for purchasing a new vehicle – this amount will be eligible for your purchase order. This amount will come from the General Fund Property/Casualty #100410101 - 64500 and will have to be expended or encumbered with a purchase order in the budget year that the damage occurred. We will need to be notified in advance of your purchase.
