**AGREEMENT BETWEEN FORT BEND COUNTY AND THE CITY OF WESTON LAKES  
FOR LAW ENFORCEMENT SERVICES**

This Agreement, made and entered into by and between Fort Bend County, Texas, a body corporate and politic acting herein by and through its Commissioners Court ("County"), and The City of Weston Lakes ("City").

**WHEREAS**, the City desires County to provide law enforcement services within and throughout the corporate limits of City; and

**WHEREAS**, the County desires to assist City in the promotion of public safety and the public interest; and

**WHEREAS**, the County has law enforcement authority in the City's geographical area; and

**WHEREAS**, this agreement is made pursuant to and under the provisions of Chapter 791, Texas Government Code, the Interlocal Cooperation Act.

**NOW, THEREFORE**, in consideration of the foregoing and further consideration of the mutual promises, covenants and conditions herein, the parties hereby agree as follows:

**BASIC TERMS**

This Agreement for Law Enforcement Services is entered into pursuant to the Primary Interlocal Agreement ("Primary Agreement") agreed to by the parties on the date this Agreement for Law Enforcement Services was signed. The terms of that Primary Agreement are incorporated into this Project Agreement by reference for all purposes as if they were set forth herein word for word.

**SERVICES PROVIDED**

Fort Bend County (through the Fort Bend County Sheriff's Office) will provide law enforcement services to City, to include all peace officer duties that County is authorized to perform within the County.

**TERM**

This Agreement shall be effective **October 1, 2009** through **September 30, 2010** and must be renewed annually thereafter. It is further understood and agreed that this Agreement may be terminated by either party by giving thirty (30) days written notice.
