**ORDER ABANDONING A PORTION OF BLAISDALE ROAD
(aka Skinner Road)
IN FORT BEND COUNTY, TEXAS**


On this the 26 day of January, 2010 at a regular meeting of the Commissioners Court of Fort Bend County, Texas, sitting as the governing body of Fort Bend County, Texas, upon motion of Commissioner Morrison seconded by Commissioner Prestage duly put and carried by unanimous vote, Commissioners Court adopts the Order to abandon a portion of Blaisdale Road (aka Skinner Road), in Fort Bend County, Texas.

After due consideration, the Court found that portion of Blaisdale Road is no longer needed by Fort Bend County and the needs of the public interest would be better served if such above described right-of-way easement was abandoned.


IT IS ORDERED that Blaisdale Road more fully described in Exhibit "A", is hereby abandoned as a county road in accordance with Transportation Code § 251.051 and that this Order be hereby filed in the Deed Records of Fort Bend County forthwith.

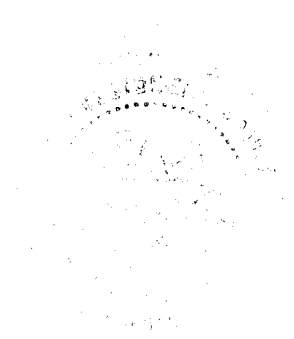

60ft Blaisdale Right-of-way description

From 5/8 inch iron rod at the northwest corner of the 62 WM Morton, Tract 7, proceed S197°00'29"W +/- 250 feet to east edge of 60 foot Blaisdale Road right-of-way. Then S225°28'10"W +/- 1087 feet along east edge of Blaisdale Road right-of-way to north edge of WM Morton, Tract 62, 92.75726 acre tract. Then continue S200°38'30"W +/- 60 feet to west edge of Blaisdale Road right-of-way. Turn and proceed N76°09'00"E +/- 1088 feet to WM Morton, Tract 10, 2.57 acres tract. Continue N17°03'23"E +/- 60 feet to mark the Blaisdale Road right-of-way.
