**ORDER ABANDONING MOATS WAY
IN FORT BEND COUNTY, TEXAS**

On this the 26 day of Jan., 2010 at a regular meeting of the Commissioners Court of Fort Bend County, Texas, sitting as the governing body of Fort Bend County, Texas, upon motion of Commissioner meyers, seconded by Commissioner Patterson duly put and carried by unanimous vote, Commissioners Court adopts the Order to abandon Moats Way, in Fort Bend County, Texas.

After due consideration, the Court finds that it has been infrequently used for more than twenty years, and is no longer needed by Fort Bend County and the needs of the public interest would be better served if such above described right-of-way easement was abandoned.

IT IS ORDERED that Moats Way, more fully described in Exhibit "A", is hereby abandoned as a county road in accordance with Transportation Code § 251.051 and § 251.057 and that this Order be hereby filed in the Deed Records of Fort Bend County forthwith.

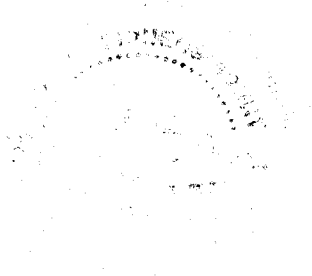

FIELD NOTES FOR THE CENTER OF A CUL-DE-SAC BEING A PART OF A 116.4058 ACRE TRACT OF LAND IN THE WILLIAM ANDRUS LEAGUE, ABSTRACT 3, FORT BEND COUNTY, TEXAS, SAID 116.4058 ACRE TRACT AS COMPOSED OF (a) THAT CERTAIN TRACT 6 (DAVIS TRACT) CALLED 14.0 ACRE TRACT MORE FULLY DESCRIBED IN VOLUME 120, PAGES 19-22 OF THE DEED RECORDS OF FORT BEND COUNTY, TEXAS, (b) 77.6578 ACRES OUT OF A 143.5 ACRE TRACT MORE FULLY DESCRIBED IN VOLUME 120, PAGES 19-22, DEED RECORDS OF FORT BEND COUNTY, TEXAS, (c) 20.4677 ACRES OF LAND BEING A PART OF TRACT C AND TRACTS D, E AND F OF THE COOK & KING SIMMONS ESTATE 66.48 ACRE TRACT MORE FULLY DESCRIBED IN VOLUME 128, PAGE 290, DEED RECORDS OF FORT BEND COUNTY, TEXAS, (d) 3.8310 ACRES OF LAND BEING A PART OF A 14.05 ACRE TRACT MORE FULLY DESCRIBED IN VOLUME 574, PAGE 290, DEED RECORDS OF FORT BEND COUNTY, TEXAS, (e) A 0.4493 ACRE TRACT OUT OF A 243.017 ACRE TRACT MORE FULLY DESCRIBED IN VOLUME 553, PAGE 266 OF THE DEED RECORDS OF FORT BEND COUNTY, TEXAS.

COMMENCING at an Iron Pipe set in the East Right-of-Way line of F. M. Highway 723 at the Southwest corner of the aforementioned called 14.0 Acre Tract, said point being the Southwest corner of the aforementioned 116.4058 Acre Tract;

THENCE North 00 degrees 37 minutes 57 seconds East along the East Right-of-Way line of F. M. Highway 723, 927.00 feet to a concrete Right-of-Way marker for an angle point in said line;

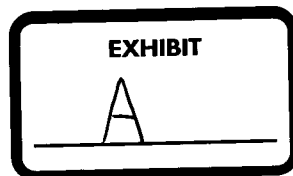
THENCE North 00 degrees 20 minutes 45 seconds West, 978.46 feet to a concrete Right-of-Way marker for an angle point in said line;

THENCE North 00 degrees 18 minutes 31 seconds West, 1098.47 feet to a concrete Right-of-Way marker for an angle point in said line;

THENCE North 00 degrees 20 minutes 00 seconds West, continuing along the East Right-of-Way line of F. M. Highway 723, 1001.80 feet to a concrete Right-of-Way marker on said line;

THENCE North 00 degrees 20 minutes 00 seconds West, 322.68 feet to a point;

THENCE North 89 degrees 40 minutes 00 seconds East, 40.00 feet to a point being the center of the herein described cul-de-sac, having a radius of 50 feet.
