Fort Bend County has been awarded a grant in the amount of \$51,810 from the Edward Byrne Memorial Justice Assistance Grant Stimulus for the purchase of criminal investigation equipment. No match is required.

I am requesting that Commissioners' Court at its January 26 session authorize the County Judge to accept the grant award.

The device to be purchased by the Fort Bend County Sheriff's Office is a Delta Sphere 360 3-D Scene Capture, Viewing and Analysis System. This equipment will be owned and operated by the Sheriff's Office but will be made available along with technical assistance to the County's municipal police departments, Texas Rangers and DPS.

Commissioners' Court applied for the grant on May 12, 2009. The application successfully competed with other applications at the regional and state levels and notification of the award was received on January 15.
