**CONTRACT FOR ENGINEERING SERVICES
SUPPLEMENTAL AGREEMENT NO. 1**

STATE OF TEXAS §

COUNTY OF FORT BEND §

THIS SUPPLEMENTAL WORK AUTHORIZATION to contract for engineering services is made by and between Fort Bend County acting by and through the Fort Bend Commissioners Court, hereinafter called the "County", and TCB Inc., now known as AECOM USA Group, Inc., hereinafter called the "Engineer", and becomes effective when fully executed by both parties.

WITNESSETH

WHEREAS, the County and the Engineer executed a contract on June 3, 2008 concerning Old Richmond Road from West Airport to FM 1464; and,

WHEREAS, Section III, Period of Performance, requires work to be completed on or before December 31, 2008; and,

WHEREAS, Section II, Compensation, limits the amount payable of the contract to \$194,621.55; and,

WHEREAS, it has become necessary to amend the contract;

AMENDMENT

NOW THEREFORE, premises considered, the County and the Engineer agree that said contract is amended as follows:

The termination date is extended to October 1, 2010

The Compensation is revised to limit the maximum amount payable of the contract to \$236,250.55.


The Fee for the revised scope of work is shown on Attachment "A".





AECOM USA Group, Inc. (AECOM) is pleased to submit the following professional services fee proposal for the preparation of the final Plans, Specifications and Estimates (PS&E) for improvements to the existing asphalt pavement on Old Richmond Road from FM 1464 (Clodine Road) to Voss Road.

This project will be designed per the Texas Department of Transportation (TxDOT) standard criteria and specifications as required for federally funded projects. The anticipated letting date for this project will be March 2010 as required to receive American Recovery and Reinvestment Act funding. Based on this letting date, AECOM will provide one submittal of construction plans on December 23 for Houston review, and final PS&E submittal for Austin review by end of January, 2010.

This project involves improvements to the existing asphalt pavement on Old Richmond Road from FM 1464 (Clodine Road) to Voss Road (approximately 9,450 linear feet). Improvements include point repairs of the existing asphalt pavement and asphalt overlay for the portion of Old Richmond Road from FM 1464 to Pecan Acres; and asphalt overlay with new asphalt shoulders from Pecan Acres to Voss Road.

Professional Engineering Services:

AECOM will prepare the PS&E package to include items discussed with TxDOT on Thursday, December 10 at 2:00 pm at the Houston District office. This will include:

- Preparation of Construction Plans
 - Title Sheet
 - Sheet Index
 - Typical Sections
 - Project Layout
 - Alignment Data/Curve Table
 - Quantity Sheets
 - Traffic Control plans and standards
 - Pavement Marking plans and standards
 - SWPPP plans and standards
- Preparation of Construction Specifications
 - Verify bid items against specifications
 - Prepare required special specifications
 - Prepare project general notes





- Preparation of Quantities and Estimates
 - Prepare quantity take-offs
 - Prepare cost estimate
 - Input quantities into TxDOT Document and Construction Information System (DCIS)
- Coordination and Submittal Efforts
 - Preparation of final submittal
 - Perform QA/QC
 - Coordination with TxDOT throughout the project including environmental coordination.

The fees for the above mentioned professional engineering services are requested on a lump sum basis. The total professional engineering fees for these services are \$41,629.00. A detailed level of effort has been included for your review.
