2009 Racial Profiling Report

Introduction

This report contains data collected in 2009 from traffic citations issued by the Fort Bend County Precinct Four Constable's Office located in Sugar Land, Texas.

Because of the qualified exemption under Texas Code of Criminal Procedure, Article 2.135, only the following data shall be reported:

1. Total number of traffic citations issued by Fort Bend County Precinct Four Deputies;
2. Percent of total citations by ethnic category;
3. Total number of consent searches;
4. Total number of non-consent searches;
5. Total number of arrests resulting from the searches or the traffic stops.

Internal Review

The internal analysis of data was compiled for future use or dissemination; however, that data was exempt from this report based on the exemption cited above.

No complaints of racial profiling were lodged against deputies in 2009.
