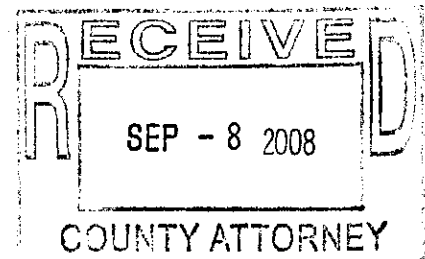

This letter is being sent for request of the abandonment of a portion of Lawson Road, which is located in the One Oak Chase Subdivision, A 169.886 Acres unrecorded subdivision in the J. A. Fetterley's Subdivision in the David Fitzgerald Survey, Abstract 25, Fort Bend County, Texas. Road & Bridge is requesting the abandonment of the portion of Lawson Road between Gussiema Lane and 931 Lawson Road. This portion of Lawson Road was taken into the maintenance system in August 9, 1994 and was never constructed to meet county standards. Over time the residents that have property that borders this portion of Lawson Road have constructed fences and closed the access. Road & Bridge does not require this portion of Lawson Road for access or egress to Gussiema Lane and has no future plans to develop this portion of roadway. At the present time this portion of roadway is a grassed road and only is accessible during drought conditions.

The residents that have property that borders the existing Lawson Road (30' Road Easement) have signed a petition in order to abandon the portion of roadway in question. All residents are in agreement and no access will be denied to surrounding property owners.

The remaining portion of Lawson Road would continue to be maintained by Road & Bridge and would remain on the Road Log as the portion from Kathy Lane to 931 Lawson Road. Appox. 1800 feet and all other descriptions the same.
