### CHANGE ORDER # 1 PROGRAM MANAGEMENT AGREEMENT

THIS CHANGE ORDER #1 to the Program Management Agreement is made and entered into by and between the Fort Bend County, a body corporate and politic under the laws of the State of Texas, acting by and through the Fort Bend County Commissioners Court, hereinafter referred to as "County," and CARTER GOBLE LEE, LLC, hereinafter referred to as "Program Manager," a Georgia Corporation authorized to conduct business in the State of Texas.

#### RECITALS:


County and Program Manager previously entered into a Program Management Agreement for the expansion of the Fort Bend County Jail dated September 26, 2006, hereinafter referred to as the "Agreement." County and Program Manager now desire to further amend said Agreement as set forth below.

#### **AGREEMENT**

For and in consideration of the premises and the mutual promises, obligations, and benefits contained herein, County and Program Manager hereby agree as follows:

- 1. An additional amount not-to-exceed \$146,192.98 shall be available as provided in Article 8.1 of the Agreement which provides that the Program Management Fee shall be determined as three percent (3%) of the Approved Project Budget, exclusive of all contingencies, Program Manager fees, Program Manager reimbursable expenses, and land acquisition costs, as described in Exhibit A, Program Manager's Fee Adjustment dated February 19, 2010, incorporated by reference as if set forth herein verbatim for all purposes.
- 2. The Program Management Fee under the Agreement and this Change Order #1 shall-not-exceed \$2,196,292.00.
- 3. No additional funding shall be available for services provided under the Agreement without prior written consent of County.
- 4. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- 5. If there is a conflict between this Change Order #1 and the Agreement, the provisions of this Change Order #1 shall prevail.
- 6. Attached hereto to this Change Order #1 is Exhibit B, Program Management Fee dated September 26, 2006, incorporated by reference as if set forth herein verbatim for all purposes.

RE: Program Management Fee Adjustment

Dear Mr. Brady,

In accordance with the Program Management Agreement, Article 8.1, the Program Management Fee shall be determined as a percentage (3%) of the total Approved Project Budget exclusive of all Contingencies, Program Management Fee, Program Management Reimbursable and land acquisition costs. Exhibit F of the Program Management Agreement contained an estimated Project Budget Amount total of \$79,759,092, which included Construction and Design Contingencies totaling \$9,372,339. Accordingly, the estimated Program Management Fee shown in Exhibits C and F of the Agreement was \$2,050,099.02.

Since the Agreement was executed, design and construction of the Project ensued and resulted in approvals of the GMP Change Order, the 100% Document Change Order, GMP contingency releases and Turner Change Order # 2. The Project contingencies were also utilized to expand the scope of the originally planned improvements. On the basis that the remaining Contingency Amount is \$4,225,081, the terms of our Agreement allows that the actual Program Management Fee to \$2,196,292.

Please amend our purchase order to include the increase in Program Management Fee in the amount of \$146,192.98 in accordance with the Program Management Agreement dated 9/26/06.
