- There is evidence of an error by the Ft Bend Central Appraisal District
- Fort Bend ISD & Fort Bend ESD #5 has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
