Hello Lou Ann,

This charge is the result of an arrest of one suspect who was driving a 18 wheeler loaded with 2000 pounds of Marijuana. We asked for a rotation wrecker from dispatch to tow the vehicle to our storage facility where it is maintained by the county. The Trailer was seized under the chapter 59 statute. We did NOT ask for a special wrecker or anything out of the ordinary, this is just what the wrecker charged that the dispatcher sent out.
