

### Order of the County Judge Appointment of Temporary Justice of the Peace Precinct One, Place Two of Fort Bend County

**Whereas**, Sara Rosas Boone was appointed temporary Justice of the Peace, Precinct 1, Place 2 on December 16, 2009 for a period of three months; and

Whereas, the County Judge finds that there is a need to extend this appointment;

Now, therefore, as County Judge of Fort Bend County, I, Robert E. 

# Order of the County Judge Appointment of Temporary Justice of the Peace Precinct One, Place Two of Fort Bend County

As County Judge of Fort Bend County, I, Robert E. Hebert hereby appoint Sara Rosas Boone, as the temporary Justice of the Peace, Precinct Number 1, Place 2, of Fort Bend County effective December 16, 2009, to serve during the absence of Judge Gary Geick. Sara Rosas Boone qualifies under the guidelines of the Texas Government Code §27.055. Her appointment shall commence on December 16, 2009 and continue until the return of Judge Geick on or about February 28, 2010, and shall not exceed three months. As the temporary justice, Sara Rosas Boone shall have all the rights and powers of the justice of the peace while serving in this capacity but may not make personnel decisions about, or significant changes in, the justice of the peace's office.
