KNOW ALL MEN BY THESE PRESENTS: That **KEITH L. BUVINGHAUSEN**, hereinafter called "Grantor", for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) cash and other good and valuable consideration to Grantor in hand paid by **FORT BEND COUNTY**, **TEXAS**, has GRANTED, SOLD, and CONVEYED, and by these presents does GRANT, SELL, and CONVEY to **FORT BEND COUNTY**, **TEXAS**, a body corporate and a political subdivision of the State of Texas, hereinafter called "Grantee", all that certain tract or parcel of land located in Fort Bend County, Texas, together with all improvements situated thereon, described as follows, to-wit:

THE SURFACE ONLY of 1.5587 acres (67,897 square feet) of land in the Randall Jones Survey, Abstract No. 42, Fort Bend County, Texas, and being out of a called 15.57 acre tract of land conveyed to Keith L. Buvinghausen, as recorded under Fort Bend County Clerk's file No. 2008101003, said tract being more particularly described on Exhibit "A" attached hereto and made a part hereof.

This conveyance is for public road and public utilities purposes and covers the SURFACE ONLY of the above-described tract of land, and no interests in minerals or royalty are conveyed to Grantee. Grantor hereby reserves unto himself and to his heirs and assigns all interests now owned by Grantor in the oil, gas and other minerals in, on, under and that may be produced from said tract of land and royalties in connection therewith; provided, however Grantor waives and relinquishes to Grantee all rights of ingress and egress to drill for, explore, develop, produce or market said oil, gas and other minerals from the surface of said tract of land except that Grantor retains the right to directionally drill under said land from other surface locations lying outside said tract of land. 
