The U.S. Department of Justice Bureau of Justice Assistance is expected to announce its next round of Justice Assistance Grant (JAG) funding shortly. In years past these funds have been used to support the criminal justice activities of eligible Fort Bend County departments

In anticipation of funding for Fort Bend County, and also of the usual brief application period, I am asking that Commissioners' Court re-appoint the JAG Review Committee. This will enable the committee to act on behalf of the Court in reviewing the grant application and in bringing a non-binding recommendation to the Court on how the funds may be spent.

Current members of the committee are CCL 3 Judge Susan Lowery, Precinct 2 Constable Ruben Davis, District Attorney's Chief Investigator, Herb Owens, and Dennis McAfee, Fort Bend County Crime Stoppers board member and Juvenile Outreach/ Grants Coordinator for the Sheriff's Office.
