The board of directors received a letter of resignation from Lee Duggan at the March 22nd board meeting. The board accepted his resignation.

Under the Sec. 6.03 (I) of the property tax code states "if a vacancy occurs on the board of directors other than a vacancy in the position held by a county assessor-collector serving as a nonvoting director, each taxing unit that is entitled to vote by this section may nominate by resolution adopted by its governing body a candidate to fill the vacancy. The unit shall submit the name of its nominee to the chief appraiser within 45 days after notification from the board of directors of the existence of the vacancy, and the chief appraiser shall prepare and deliver to the board of directors within the next five days a list of the nominees. The board of directors shall elect by majority votes of its members one of the nominees to fill the vacancy."

Submission of nominees must be done by May 9th. Mr. Whitehead will then prepare a list of the nominees for the board. The board will then elect the new member at the regular board of directors meeting May 17, 2010.
