Mr. Yang is requesting waiver of penalty and interest on the above referenced account for the 2009 tax year because he states that he did not receive his tax statement.

## Tax Office records indicate:

- Original deed #2009101855 was recorded on September 28, 2009 with the owner listed as Dong Yang & Yading Zhou, 3535 Woodmere Lane, Sugar Land, TX 77478.
- November 5, 2009--2009 October Name change added Yang Dong & Yading Zhou, 3535 Woodmere Ln, Sugar Land, TX 77478-5842.
- 2009 Original Statement was requested by Wells Fargo Mortgage Company by electronic request.
- Mr. Yang stated in his letter that he received one statement from First Colony LID, which he paid in January 2010. He also stated that he knew his estimated amount of property taxes would be around \$3000.00. He stated he did online research and found the following taxing entities for his property as: Fort Bend ISD, City of Sugar Land, Fort Bend County General Fund, First Colony LID and Fort Bend County Drainage District. He stated he called FBISD and he was told they did not collect the taxes anymore. He stated he attended a homebuyer work shop at work in February 2010 and he indicated he ask about this and was told to call the County Tax Office. Mr. Yang called the Fort Bend County Tax Office on February 16, 2010 and a tax clerk informed him of the delinquent taxes due and sent him a statement.
- There is evidence of an error during data transfer in the tax office.
- Fort Bend ISD & City of Sugar Land has authorized Fort Bend County Tax Office to handle the
  processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court
  to make the determination based on 33.011 of the State Property Tax Code.

I <u>do</u> recommend waiver of penalty and interest. Property Tax Code Section 33.011 (a) (1). "The governing body of a taxing unit: shall waive penalties and may provide for the waiver of interest on a delinquent tax if an act or omission of an officer, employee, or agent of the taxing unit or the appraisal district in which the taxing unit participates caused or resulted in the taxpayer's failure to pay the tax before delinquency..."

# Request to Waive the Property Tax Penalty on 3535 Woodmere Lane, Sugar Land

Dear Sir/Madam,

My name is Dong Yang; I bought a house (3535 Woodmere Lane, Sugar Land, TX, 77478) at the end of Sep. 2009. I just paid my property tax in full (including a penalty of \$205.72). I wondered if you can help to waive the penalty for the following reasons:

- 1. I received only 1 bill from FIRST COLONY LID, which I paid in full in Jan, 2010. The Fort Bend Tax office sent the rest of the property tax bills to Wells Fargo instead of sending them to me.
- 2. I am a first time house owner; my wife recently got pregnant, neither of us has much knowledge about how property tax works.
- 3. I do know the estimated amount of my property tax should be around \$3000.00 something yearly, and the bill I received from FIRST COLONY LID is \$307, which I figured may be is a monthly bill. I paid the \$307 but I didn't get any other bills by the end of Jan, 2010. So I did some online research, seems the property tax details from previous owner of the house in year 2008 were shown as:

FORT BEND ISD 1.2500 FORT BEND CO GNRL FND 0.4987 CITY OF SUGAR LAND 0.3000 FIRST COLONY LID 0.1946 FORT BEND CO DRAINAGE 0.0180 COUNTY JUDGE RECEIVED FEB 23 2010

I really have no idea what these are for, so I googled the major item "FORT BEND ISD ", and I got the website of Ford Bend Independent District. I called them and was told they don't handle property tax any more. This really confused me what to do next.

- 4. In Feb, 2010, I attended a homebuyer work shop at work. I asked my question to the presenter, she suggested me to call Fort Bend County.
- 5. I called Fort Bend County and was told the property tax bills were sent to Wells Fargo instead of me in December 2009. So they sent me the bills few days later along with this penalty waiver request instruction. I paid the tax with the penalty right away. That is how I end up here requesting your help.

I understand the situation I presented to you sound a little complicated, I really appreciate your time and efforts in helping me out.
