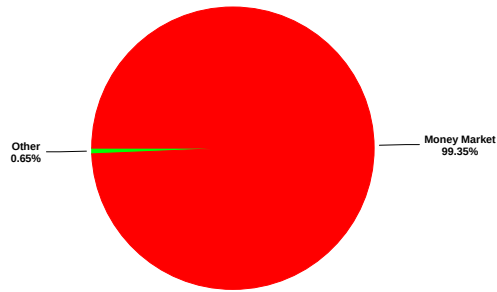

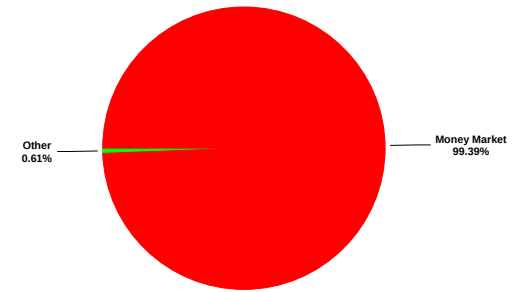

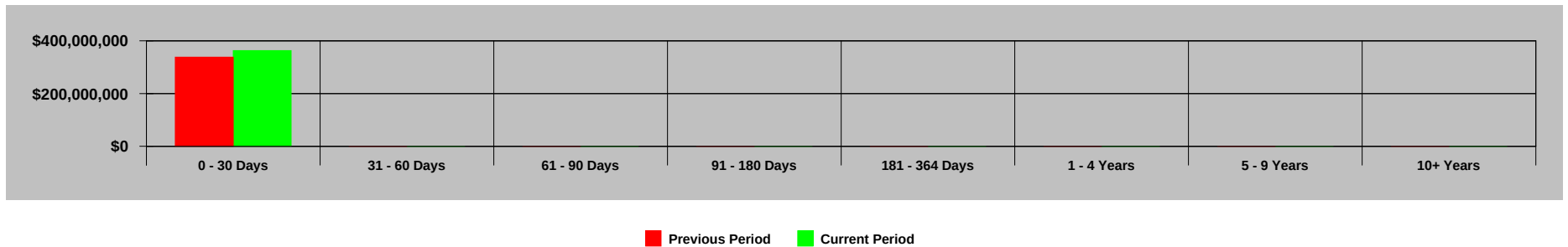
Portfolio Composition - 01/31/10



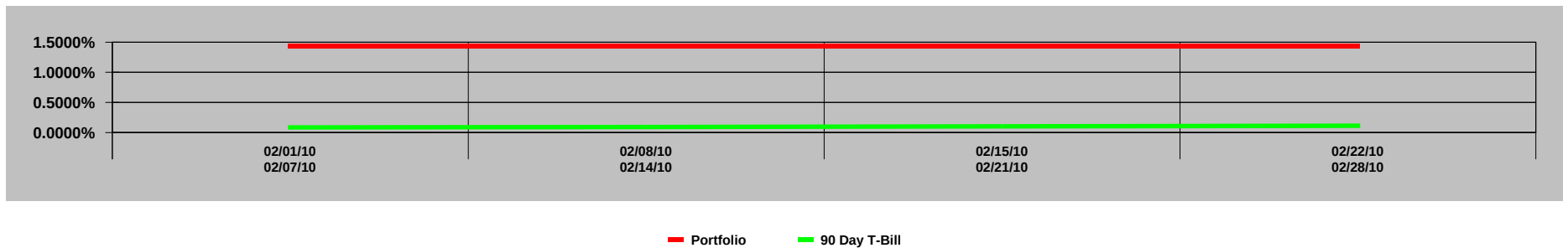
Portfolio Composition - 02/28/10
