**CONTRACT FOR ROUTINE TRANSPORTATION SERVICES FOR
FORT BEND COUNTY AMENDMENT NO. 2**

THIS AMENDMENT, is made and entered into by and between Fort Bend County, (hereinafter referred to as "County"), and GBJ, Inc., dba, AFC Corporate Transportation (hereinafter referred to as "Contractor").

THAT WHEREAS, the parties executed and accepted that certain Contract for Routine Transportation Services for Fort Bend County, ("Agreement"), on February 7, 2006, and as renewed on April 1, 2007, April 1, 2008, October 1, 2008, and October 1, 2009, and as amended on December 11, 2007, incorporated by reference herein for all purposes; and,

WHEREAS, the parties desire to amend the agreement to include an additional service plan.

NOW, THEREFORE, the following changes are incorporated as if a part of the original Agreement:

Additional transportation services shall be provided to the Texas Medical Center area as described in the Texas Medical Center Service Plan, attached hereto as Exhibit A.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.



EXHIBIT A

**Fort Bend County
Texas Medical Center (TMC) Area Service Plan**

Service start will commence on June 1, 2010 and continue for 12 months subject to annual renewals. Contractor will work with Fort Bend County to finalize planning and design for services from Fort Bend County into the Texas Medical Center Area of Houston. Initial planning is projecting utilization of five (5) ~~30~~ ²⁰ passenger capacity mini-buses with capacity for 2 wheelchair tie-downs. One (1) 15 passenger capacity mini-bus (and driver) with capacity for 2 wheelchair tie-downs from the existing demand response program will also be part of the service plan but is not to be considered as an additional service need.. Budget funding for this vehicle and staffing is already a part of the existing demand response budget. A portion of its service day will be repositioned to accommodate route needs for the TMC service. Wheelchair tie-down, bus access and bus design must be in compliance with the design standards set forth in the Americans with Disabilities Act. Primary operating hours are planned from 5:05 a.m. to 9:10 a.m. and 3:40 p.m. to 8:17 p.m. Service days are planned as Monday thru Friday excluding County Holidays. Service hours and days will change throughout the contract period based on passenger use and funding. Contractor will be allowed to bill one service hour per day per bus at the approved contract service hour rate to allow for deadhead miles between the depot and the route start and end for buses stored at Contractor Headquarters in Houston. Buses will operate with no more than a 30 minute headway.

The route will begin and end at the Fort Bend County Fairgrounds on Highway 36 in Richmond. The route will then travel to the parking lot of the University of Houston Sugar Land Campus at University Boulevard and Highway 59, then to the AMC Movie Theatre at Sweetwater Boulevard and Towne Center Boulevard for the third stop. The route continues from there northbound on the Highway 59 HOV exiting at Main and heading south. The buses will continue south to destinations along Pressler, Bertner, and Ross Sterling, then to the Veteran's Hospital on Almeda. The afternoon schedule will operate in reverse of the morning schedule.

Contractor will be responsible for management and supervision of all aspects of the service and any sub-contractors in accordance with the terms set forth within the contract. Contractor will also be responsible for providing reserve vehicles and drivers available at route locations within ½ hour of notification of need.

FARES

Fares will be established once the service parameters are defined. Tickets will be provided by Fort Bend County.

SUPPORT SERVICES

All support services defined in the contract will be required for this service plan (Texas Medical Center Area).
