## AN ORDER APPROVING THE CREATION OF THE FORT BEND GRAND PARKWAY TOLL ROAD AUTHORITY; APPROVING THE ARTICLES OF INCORPORATION AND THE BYLAWS THEREOF; AND CONTAINING FINDINGS AND OTHER PROVISIONS RELATING TO THE SUBJECT

WHEREAS, Section 431.101 of Chapter 431 of Texas Transportation Code ("Chapter 431") authorizes the creation and organization of public non-profit local government corporations to act as a duly constituted authority of a county to aid and assist the county in the performance of one or more governmental functions; and

WHEREAS, Section 431.102 of Chapter 431 requires a local government corporation to be created pursuant to provisions of Chapter 394, Texas Local Government Code ("Chapter 394"); a local government corporation's articles of incorporation and bylaws shall be in the form and be executed, approved, and filed in the manner prescribed by Chapter 394; and

WHEREAS, a local government corporation may have and exercise all of the powers prescribed by Chapter 394, Chapter 431 and Article 1396-1.01 et seq., Vernon's Texas Civil Statutes, as amended (collectively, the "Acts"); and

WHEREAS, Chapter 394 requires as a condition to the creation of a local government corporation that at least three (3) residents of the county who are citizens of the state and at least eighteen (18) years of age submit a written application for the incorporation of the local government corporation; and

WHEREAS, there has been presented to and filed with the County an application executed by three (3) residents of the County who meet the requirements of Chapter 394 requesting the incorporation of the Fort Bend Grand Parkway Toll Road Authority (the "Authority"); and

WHEREAS, Senate Bill 792 (Acts 2007, 80<sup>th</sup> Legislature, Reg. Session) (the "Act") provided seven counties, including Fort Bend County, the right to develop State Highway 99 (the "Grand Parkway"); and

WHEREAS, since 2007, Fort Bend, Harris, Montgomery, Liberty, Chambers, Galveston and Brazoria Counties (the "Counties") have been engaged in the process set forth in the Act for the development of the Grand Parkway; and

WHEREAS, on September 7, 2009, the County exercised its right to develop the portion of the Grand Parkway within the County; and

WHEREAS, the development of the Grand Parkway must comply with the Terms and Conditions that were approved by the Texas Department of Transportation ("TxDOT"), the Houston-Galveston Area Council, and the Counties; and

WHEREAS, the Grand Parkway must be developed as a "stand alone" facility and revenues from the Grand Parkway must be used solely for the completion of the entire Grand Parkway until the ultimate project is completed; and

WHEREAS, County Commissioners Court desires to grant the application for incorporation of the Authority, authorize its Articles of Incorporation, approve its Bylaws, and take other action with respect to the Authority; NOW, THEREFORE:

BE IT RESOLVED BY THE COUNTY COMMISSIONERS COURT OF THE COUNTY OF FORT BEND, TEXAS:

**Section 1.** The County Commissioners Court hereby finds, determines, and declares that the application for the incorporation of the Authority is executed and filed in the manner required by Chapter 394 and the County Commissioners Court therefore has authority to consider and act on the application for incorporation of the Authority.

Section 2. The County Commissioners Court hereby finds, determines, recites and declares that it is wise, expedient, necessary, and advisable that the Authority be formed, the creation and organization of the Authority under the provisions of the Acts and Chapter 394 as a duly constituted authority of the County is hereby approved, and the Authority is hereby authorized to aid, assist, and act on behalf of the County in the performance of its essential governmental purposes, specifically to assist the County in conjunction with the appropriate local governmental entities where necessary to develop the Grand Parkway, including without limitation, planning, designing, acquiring, financing, building, extending and improving causeways, bridges, tunnels, turnpikes, highways, overpasses, underpasses, interchanges, entrance plazas, toll houses, service stations, approaches, fixtures, accessories and necessary equipment, including drainage facilities (the "Projects"); and to perform the other purposes described in the Articles of Incorporation.

Section 3. The Authority is created as a local government corporation pursuant to the Acts and shall be a governmental unit within the meaning of Section 101.001 Texas Civil Practice and Remedies Code. The Authority shall have the power to acquire land in accordance with the Act as amended from time to time. The Authority shall have the power to purchase land for rights-of-way or obtain such land through use of eminent domain. The Authority shall have the power to borrow, including but not limited to contractual obligations, bonds and notes, to meet any expenses or needs associated with the operations of the Authority or any capital improvements undertaken by the Authority.

- **Section 4.** The County Commissioners Court hereby authorizes the Authority to work directly with the Texas Department of Transportation, federal agencies, and other local subdivisions in developing the Projects and performing all actions authorized under the Acts, the Articles of Incorporation and the Bylaws.
- **Section 5.** The County Commissioners Court hereby approves the Articles of Incorporation of the Authority in substantially the form attached hereto as Exhibit "A" and authorizes the incorporators of the Authority to file such Articles of Incorporation with the Secretary of State of the State of Texas in the manner provided by law.
- **Section 6.** The County Commissioners Court hereby approves the Bylaws of the Authority in substantially the form attached hereto as Exhibit "B".
- **Section 7.** The County Commissioners Court hereby finds, determines, recites, and declares that any notes, bonds, loans, debts or other obligations of the Authority shall not be deemed an indebtedness, liability, general or moral obligation or pledge of the faith or credit of the County of Fort Bend, or any political subdivision or governmental unit, unless such entities specifically consent to such an obligation or pledge, nor shall any such notes, bonds, loans, debts or other obligations constitute an indebtedness within the meaning of any constitutional or statutory debt limitation or restriction or indebtedness of the County or of the State of Texas within the meaning of any constitutional or statutory provision whatsoever.
- **Section 8.** The County Commissioners Court hereby finds, determines, recites, and declares that it is the purpose, intent, and desire of the County in approving the creation of the Authority and its Articles of Incorporation and Bylaws, that such actions and the Authority hereby authorized comply with the requirements of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations and Internal Revenue Service rulings promulgated thereunder and the rulings issued pursuant thereto, such that the Authority shall be deemed to be a constituted authority acting on behalf of the County pursuant to the provisions of the Acts and Chapter 394, Local Government Code.
- **Section 9.** This Order shall take effect immediately upon its passage and approval by the County Commissioners Court.
