## AGREEMENT AND RELEASE

- 1. WHEREAS, the New Territory Residential Community Association, Inc. (hereinafter referred to as "Association") provided services to Fort Bend County, Texas, (hereinafter referred to as "County") for maintaining county owned real property for approximately twenty (20) years, including the replacement of fencing and mowing located at 239 Birchill Drive and 427 Planetree, (hereinafter referred to as "County lots") located in Fort Bend County, Texas; and,
- 2. WHEREAS, the Parties hereto desire to compromise and settle any claims between themselves and are entering into this Agreement and Release (the "Agreement") for the purpose of compromising and settling any claims.
- 3. Now therefore and in consideration of the mutual covenants, representations and promises made herein, and other good and valuable consideration, which is hereby acknowledged and confessed, the Parties do hereby covenant and agree as follows:
  - (a) All parties shall execute the Agreement:
  - (b) County shall pay to the Association the amount of \$22,702.00 for all services provided at the County lots.
- 4. In consideration of the agreements set forth below and in paragraph 3 above and other good and sufficient consideration, the receipt and adequacy of which are hereby acknowledged, the Association hereby DISMISSES, RELEASES and FOREVER DISCHARGES and by these presents for itself and its successors and assigns DISMISSES, RELEASES and FOREVER DISCHARGES Fort Bend County, Texas, all agents, servants, employees, officers, attorneys, successors and assigns and all other person, natural or corporate, in privity with them, or any of them from all claims, demands, debts, obligations, liabilities, suits, liens, bond claims, causes of action or actions at law or in equity under any state or federal statute or law, all actual, consequential and exemplary damages, expenses, costs (including reasonable attorney's fees) and all other damages of any kind whatsoever, as they relate to services provided by the Association to the County for the County lots.
- 5. The Agreement is made in compromise and settlement of all disputed and undisputed claims as between the Parties and is made for the promises and consideration stated herein and for the reason that such parties may buy their peace without incurring the expense of litigation.
- 6. The Agreement has been made and executed in the State of Texas and shall in all respects be governed by the laws of the State of Texas. Venue of any dispute or action regarding the Agreement shall be in Fort Bend County, Texas. In the event that one or more of the provisions contained herein shall for any reason be held to be invalid, the Agreement shall be continued as if such invalid or unenforceable provision had never been contained herein.
- 7. The undersigned, each of whom executes the Agreement, represents that each has read the Agreement, and that each fully understands the same and that it is executed for the consideration herein expressed, the receipt and sufficiency of which is hereby expressly acknowledged and confessed, and that each party who executes the Agreement in a representative capacity does so with full authority to do so.
