# AMENDMENT NO. 1 TO FY2005 SUB-AWARD AGREEMENT BY AND BETWEEN FORT BEND COUNTY, TEXAS AND FORT BEND COUNTY FRESH WATER SUPPLY DISTRICT NO. 1

THIS AMENDMENT is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Fort Bend County Fresh Water Supply District No. 1 (hereinafter "FB1"), a political subdivision of the State of Texas, organized and operating pursuant to the provisions of Article XVI, Section 59 of the Texas Constitution and Chapters 49 and 53 of the Texas Water Code.

WHEREAS, the parties executed and accepted that certain FY2005 Sub-Award Agreement By and Between Fort Bend County, Texas and Fort Bend County Fresh Water Supply District No.1, (hereinafter "Agreement"), on June 3, 2008, attached hereto as Exhibit A and incorporated by reference herein for all purposes; and

WHEREAS, the grant project period for FY2005 Environmental Protection Agency State and Tribal Assistance Grant, Assistance Agreement No. XP-96609501-0, has been extended to December 31, 2011; and

WHEREAS, the parties desire to amend the Agreement to extend the project period and revise the existing project schedule.

NOW THEREFORE, the following changes are incorporated as if part of the original Agreement:

- 1. The project period shall end on December 31, 2011.
- 2. FB1 agrees that it must expeditiously initiate and complete the remaining project tasks in accordance with the following project schedule:

November 2010	Advertise for construction bids

February 2011-October 2011	Start and complete construction
