## AMENDMENT NUMBER 1

## TEXAS HISTORICAL COMMISSION COURTHOUSE PRESERVATION PROGRAM FUNDING AGREEMENT ROUND VI DATED May 24, 2010

The funding agreement between the Texas Historical Commission and Fort Bend County is hereby amended as follows:

1. Delete the current section 4.01 and replace it with the following:

ARTICLE IV SECTION 4.01

The amount of the grant under this Program that is subject to this Agreement shall not exceed \$308,994. The grant of funds shall be paid to the County in accordance with the procedure described in Article VII hereof.

2. Delete the Verification of Funds Match (Attachment "A") and replace it with the following:

All other provisions of this contract shall remain unchanged and in full force and effect.

Dear Judge Hebert,

Congratulations! At the quarterly meeting last week in Austin, the Texas Historical Commission voted to award your county supplemental funding to your Round VI planning grant through the Texas Historic Courthouse Preservation Program. Funds allocated to another planning project were not awarded, making additional funds available in this round.

The amount of \$37,947 has been awarded to Fort Bend County increasing the amount of state share of the planning project cost from a 2/3 state match (66.666%) with a 33.333% local match to a 76.0% state match with a 24% local match. This now higher percentage of state funding is more typical of the match in previous rounds and should allow the county to decrease commensurately its share of the funds required to complete the planning work.

The Fort Bend County Courthouse restoration project was previously awarded \$271,047 in state funds with a county match of \$135,524. With this supplemental award of \$37,947 the state contribution has been raised to \$308,994. The supplemental funds will be available to you as a new 76% reimbursement rate on future reimbursements. As previously, 10% of the total state award will be held until final completion of the project with the submittal and our approval of a 95% complete set of construction documents and opinion of probable cost.

An amendment to the Funding Agreement is required for the supplemental award. This is provided herein along with applicable revisions to Source of Funds Statement, attachment "A".
