Constable's commission on an execution or an order of sale, in addition to the fees above, when the same is made by a sale, for the first One Hundred Dollars (\$100) or less, ten percent (10%); for the second One Hundred Dollars (\$100), seven percent (7%); for all sums over Two Hundred Dollars (\$200) and not exceeding One Thousand Dollars (\$1,000), four percent (4%); for all sums over One Thousand Dollars (\$1,000) and not exceeding Five Thousand Dollars (\$5,000), two percent (2%); for all sums over Five Thousand Dollars (\$5,000), one percent (1%). When the money is collected by the Constable without a sale, one-half (1/2) of the above commission shall be allowed. Tax sales held are not subject to any additional commission. The fees described as "Tax Sale-Sold or Cancelled" and "Tax Resale-Sold/Cancelled" shall include fees and commissions necessary to effectuate a sale (including all required notices, constable sale posting, preparation of a tax deed).

CHECKS FOR SERVICE SHOULD BE MADE PAYABLE TO CONSTABLES OF FORT BEND COUNTY.

FOR SERVICE OF PROCESS OUT OF FORT BEND COUNTY, THE ABOVE FEES ALONG WITH THE FEE SCHEDULE TITLED "FORT BEND COUNTY CONSTABLES EXPENSE FOR OUT OF COUNTY PROCESS/WRITS OF ATTACHMENT EFFECTIVE JANUARY 1, 2011" SHALL BE COMBINED.
