RESOLUTION TO ABANDON MANOR ROAD FROM APPROXIMATELY 300' FEET NORTH OF LJ PARKWAY TO APPROXIMATELY 200' FEET SOUTH OF WINDING WATERS LANE IN FORT BEND COUNTY, TEXAS

WHEREAS, Fort Bend County acquired Manor Road (formerly Loop Road), dedicated to Fort Bend County by 60 ft. Easement Instrument, Vol. #2235, Pg. 673, and Vol. #2253, Pg. 1498, and by Release of Easement and Satisfaction of Judgment as described in Vol. 2401, Pg. 668, of Fort Bend County records, and accepted it for maintenance in the County Road Log on August 13, 1990; and,

WHEREAS, the portion of Manor Road to be abandoned runs north and south from approximately 300' feet north of LJ Parkway to approximately 200' feet south of Winding Waters Lane; and,

WHEREAS, the replacement road will be LJ Parkway, and immediately, a temporary replacement of Manor Road will be built to accommodate the traffic; and,

WHEREAS, that portion of Manor Road is to be abandoned was closed by the County approximately three (3) months ago and the temporary replacement of Manor Road has been built and is currently being utilized; and,

WHEREAS, that portion of Manor Road that is to be abandoned, is no longer needed, and Fort Bend County desires to abandon it;

THEREFORE, on this date the Commissioners Court of Fort Bend County abandons that portion of Manor Road, from approximately 300' feet north of LJ Parkway to approximately 200' feet south of Winding Waters Lane, as shown on the field notes and attached hereto as Exhibits "A" and "B".






