PUBLIC TRANSPORTATION PGA AMENDMENT #3

THIS AMENDMENT IS MADE BY AND BETWEEN the State of Texas, acting through the Texas Department of Transportation, hereinafter called the "State", and Fort Bend County hereinafter called the "Subrecipient".

WHEREAS, the State and the Subrecipient executed RPT 0903(12)32 effective August 10, 2009 to effectuate their agreement to provide public transportation; and

WHEREAS, the end date of said grant agreement was August 31, 2010; and

WHEREAS, the Subrecipient made a written request to the State dated June 14, 2010 to extend the end date of RPT 0903(12)32 based on a delivery delay of a transit vehicle due to a production facility fire; and

WHEREAS, the extension request was received by the State prior to the end date of August 31, 2010; and

WHEREAS, due to an inadvertent oversight by the State, the request for extension was not processed timely; RPT 0903(12)32 subsequently expired prior to actual delivery of the vehicle making it necessary to amend and extend said grant agreement so that a hardship is not created for Subrecipient.

NOW THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the parties hereto, the State and the Subrecipient do agree as follows:

AGREEMENT

Article 1. Description of Amended Items

The end date in ARTICLE 1. GRANT TIME PERIOD of the original grant agreement RPT 0903 (12) 32 is extended until **December 31, 2010**, unless terminated or otherwise modified as hereinafter provided.

All other provisions of the original grant agreement are unchanged and remain in full force and effect. This amendment has an effective date of **August 31, 2010** upon full execution by both parties.

Article 2. Signatory Warranty

The signatories to this amendment warrant that each has the authority to enter into this agreement on behalf of the organization they represent.
