

RESOLUTION AUTHORIZING SIGNATORS

WHEREAS, on or about February 13, 2009, it was announced that the United States Department of Housing and Urban Development (HUD) had been appropriated \$1,314,990,193 in Community Development Block Grant (CDBG) Disaster Recovery funds to make available to affected states for recovery efforts associated with Hurricanes Ike and Dolly; and

WHEREAS, Governor Rick Perry designated the Texas Department of Rural Affairs (TDRA) as the primary state agency to oversee the allocation and administration of these funds and the Texas Department of Housing and Community Affairs (TDHCA), in coordination with TDRA, to administer housing programs utilizing those CDBG funds; and

WHEREAS, Fort Bend County must request funds from the Texas Department of Rural Affairs on specified forms with signatures from persons authorized to sign these specified forms.


NOW, THEREFORE BE IT RESOLVED THAT, the persons occupying the following positions are designated as signators for the TDRA forms requesting funds from TDRA:
