On behalf of the residents of Pecan Grove Municipal Utility District ("Pecan Grove MUD"), I submit the following comments regarding the 2011 redistricting of the Fort Bend County Precincts. Pecan Grove Subdivision/MUD is in an unincorporated part of Fort Bend County. Pecan Grove depends on Fort Bend County for Police (Sheriff's Dept), Emergency Medical Fort Bend County EMS, Street Repairs & Maintenance Fort Bend County Road & Bridge, Drainage Fort Bend County Drainage District, Storm Debris Fort Bend County Engineering, Emergency Management Coordination Fort Bend County Office of Emergency Management and most importantly for our Contract Deputy Patrol (for additional security) Fort Bend County Precinct 3 Constable Rob Cook.

Compared to Quail Valley and other subdivisions that are in an incorporated City, like the City of Missouri City, which has Missouri City Police, Missouri City Fire and EMS, Public Works for Streets and drainage. Missouri City also has an Office of Emergency Management, so that the City's citizens coordinate with the City, not the County.

Pecan Grove depends on Fort Bend County. It is important to Pecan Grove residents to stay in Precinct 3. Do to the aging road infrastructure the Home Owners Associations and MUD have worked with Commissioner Meyers on multiple projects within the community. We have a rapport with our County Commissioner that we want to keep. We want to keep our continuity, our Commissioner, our Justice of the Peace and our Constable.

We elected a Justice of the Peace from our neighborhood. Keeping Ken Cannata as our JP is important to us. Our MUD recently contracted with Constable Cook for the Contract Deputy Patrol. Our residents are very pleased with Constable Cook and keeping Constable Cook is important to us.

We depend on Fort Bend County Precinct 3 for almost all of our services and are asking the Commissioners Court to keep Pecan Grove in Precinct 3.
