RESOLUTION AND ORDER DECREEING THE ACQUISITION OF PROPERTY TO BE A PUBLIC NECESSITY AND AUTHORIZING THE ACQUISITION AND PAYMENT OF COMPENSATION

WHEREAS, on the H day of January, 2011, at a regular meeting of the Commissioners Court of Fort Bend County, Texas, sitting as the governing body of Fort Bend County and Fort Bend County Drainage District, upon motion of Commissioner Weyers, seconded by Commissioner Prestage, duly put and carried:

RESOLUTION

RESOLVED THAT WHEREAS, the Commissioners Court sitting as the governing body of Fort Bend County Drainage District has received and reviewed the plans for a public project known as the Fulshear Creek Drainage Project, located along Fulshear Creek, in Fort Bend County, Texas; and,

WHEREAS, Commissioners Court has determined that public necessity and convenience exists for the location, alignment, construction, operation, and maintenance of a public project known as Fulshear Creek Drainage Project, located along Fulshear Creek from the northern property line of the Fred Bray property to the northern property line of the Christiaan Stevens property, in Fort Bend County, Texas, in accordance with said plans, alignment, and tract identifications which are part hereof:

IT IS FURTHER ORDERED AND DECREED that the County Judge or designated representative be authorized and directed to sign any papers or agreements associated with closing the purchase(s); the County Attorney, County Clerk, County Auditor and County Treasurer be authorized and directed to perform any and all necessary acts within their respective spheres of official duties toward the final acquisition of the tract(s) of land, or interest(s) therein, together with the improvement if any, within the said public project known as Fulshear Creek Drainage Project, located Fulshear Creek, in Fort Bend County, Texas and the payment and compensation therefore.
