WHEREAS, pursuant to authority contained in the Easement KMTP currently owns and operates a 24" diameter pipeline which crosses on, over, along, through and across the "Owned Premises"

WHEREAS, KMTP and Grantor desire to modify and amend the rights granted to KMTP in the Easement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements herein contained, KMTP and Grantor hereby agree to amend and modify the Easement as follows:

"The rights granted by the Easement shall be amended to include additional rights which will allow for the transportation of natural gas, oil, crude, gas petroleum products, condensates and distillates including inert gases or natural gas liquids and other hydrocarbon substances which can be transported through a pipeline."

Except as provided for above, all other terms and conditions of the Pipeline Easement Agreement remain in full force and effect.

This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective legal representatives, successors and permitted assigns

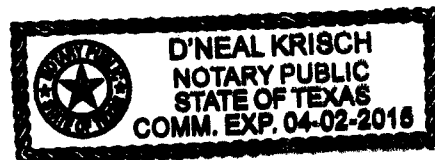
