**ADDENDUM TO CISCO CATALYST  
SWITCH INTALLATION AGREEMENT**

THIS AMENDMENT is entered into by and between Fort Bend County, a body corporate and politic, and Datavox, Inc., a company authorized to conduct business in the State of Texas.

THAT, WHEREAS, the parties have executed and accepted that certain Services Agreement, (hereinafter the "Agreement"), attached hereto as Exhibit "A" and incorporated by reference; and

WHEREAS, the following changes are incorporated as if a part of the Agreement:

1. **Time of Performance.** It is understood and agreed that the time for performance of the Scope of Services under this Agreement shall begin with receipt of the Notice to Proceed and end no later than eighty (80) days thereafter.
2. **Payment.** Upon completion of the services described in the attached Exhibit A, Datavox, Inc. shall submit to Fort Bend County two (2) original copies of invoices showing the amounts due for services performed in a form acceptable to Fort Bend County. Fort Bend County shall review such invoices and approve them within 30 calendar days with such modifications as are consistent with this Agreement and forward same to the Auditor for processing. Fort Bend County shall pay each such approved invoice within thirty (30) calendar days. Fort Bend County reserves the right to withhold payment pending verification of satisfactory work performed.
3. **Taxes.** Fort Bend County is a body corporate and politic under the laws of the State of Texas and claims exemption from sales and use taxes. A copy of a tax-exempt certificate will be furnished upon request.
4. **Applicable Law.** This Agreement shall be construed under and in accordance with the laws of the State of Texas, and all obligations of the parties created hereunder are performable in Fort Bend County, Texas. Venue shall lie in Fort Bend County, Texas, for any suit regarding the Agreement.
5. **Indemnity.** **DATAVOX, INC. SHALL SAVE HARMLESS FORT BEND COUNTY FROM AND AGAINST ALL CLAIMS, LIABILITY, AND EXPENSES, INCLUDING REASONABLE ATTORNEYS FEES, ARISING FROM ACTIVITIES OF DATAVOX, INC., ITS AGENTS, SERVANTS OR EMPLOYEES, PERFORMED UNDER THIS AGREEMENT THAT RESULT FROM THE NEGLIGENT ACT, ERROR, OR OMISSION OF DATAVOX, INC. OR ANY OF DATAVOX, INC.'S AGENTS, SERVANTS OR EMPLOYEES.**
6. **Insurance.** Prior to commencement of the Services, Datavox, Inc. shall furnish Fort Bend County with evidence of all insurance required and provide that such insurance shall not be canceled, except on 30 days' prior written notice to Fort

Bend County. Datavox, Inc. shall maintain such insurance coverage from the time Services commence until Services are completed. Datavox, Inc. shall obtain such insurance written on an Occurrence form from such companies having Bests rating of A/VII or better, licensed or approved to transact business in the State of Texas.

- a. Datavox, Inc. shall obtain such insurance of the following types and minimum limits:
    - i. Workers' Compensation insurance in accordance with the laws of the State of Texas. Substitutes to genuine Workers' Compensation Insurance will not be allowed.
    - ii. Employers' Liability insurance with limits of not less than \$1,000,000 per injury by accident, \$1,000,000 per injury by disease, and \$1,000,000 per bodily injury by disease.
    - iii. Commercial general liability insurance with a limit of not less than \$1,000,000 each occurrence and \$2,000,000 in the annual aggregate. Policy shall cover liability for bodily injury, personal injury, and property damage and products/completed operations arising out of the business operations of the policyholder.
    - iv. Business Automobile Liability insurance with a combined Bodily Injury/Property Damage limit of not less than \$1,000,000 each accident. The policy shall cover liability arising from the operation of licensed vehicles by policyholder.
    - v. Professional Liability insurance with limits not less than \$1,000,000.
  - b. Fort Bend County and the members of Commissioners Court shall be named as additional insured to all required coverage except for Workers' Compensation. All Liability policies written on behalf of Datavox, Inc. shall contain a waiver of subrogation in favor of Fort Bend County and members of Commissioners Court.
  - c. If required coverage is written on a claims-made basis, Datavox, Inc. warrants that any retroactive date applicable to coverage under the policy precedes the effective date of the contract; and that continuous coverage will be maintained or an extended discovery period will be exercised for a period of 2 years beginning from the time that work under the Agreement is completed.
7. **Limitation of Liability.** The section of the Services Agreement entitled Limitation of Liability shall be revised to read as follows: IN NO EVENT SHALL DATAVOX BE LIABLE TO FORT BEND COUNTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES OF ANY KIND WHATSOEVER, ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES; DATAVOX'S ENTIRE LIABILITY AND FORT BEND COUNTY'S EXCLUSIVE REMEDY FOR DAMAGES FROM ANY CAUSE WHATSOEVER, INCLUDING, BUT NOT LIMITED TO NONPERFORMANCE, AND REGARDLESS OF THE FORM OF ACTIONS, SHALL BE LIMITED TO THE AMOUNT WHICH HAS BEEN ACTUALLY PAID TO DATAVOX BY FORT BEND COUNTY FOR SERVICES AND/OR PERFORMANCE HEREUNDER.

8. **Independent Contractor.** In the performance of work or services hereunder, Datavox, Inc. shall be deemed an independent contractor, and any of its agents, employees, officers, or volunteers performing work required hereunder shall be deemed solely as employees of Datavox, Inc. or, where permitted, of its subcontractors. Datavox, Inc. and its agents, employees, officers, or volunteers shall not, by performing work pursuant to this Agreement, be deemed to be employees, agents, or servants of Fort Bend County and shall not be entitled to any of the privileges or benefits of Fort Bend County employment.
9. **Limit of Appropriation.** Prior to the execution of this Agreement, Datavox, Inc. has been advised by Fort Bend County, and Datavox, Inc. clearly understands and agrees, such understanding and agreement being of the absolute essence to this Agreement, that Fort Bend County shall have available the total maximum sum of three hundred and thirty-nine thousand five hundred and eighty-five dollars and 50/100 (\$339,585.50), including reimbursable expenses, if any, specifically allocated to fully discharge any and all liabilities which may be incurred by Fort Bend County. Datavox, Inc. does further understand and agree, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum compensation that Datavox, Inc. may become entitled to hereunder and the total maximum sum that Fort Bend County shall become liable to pay to Datavox, Inc. hereunder shall not under any conditions, circumstances or interpretations thereof exceed the sum of three hundred and thirty-nine thousand five hundred and eighty-five dollars and 50/100 (\$339,585.50) for all products and services described herein.
10. **Reimbursables.** All travel reimbursements are subject to the Fort Bend County Travel Reimbursement Requirements for Fort Bend County Vendors.

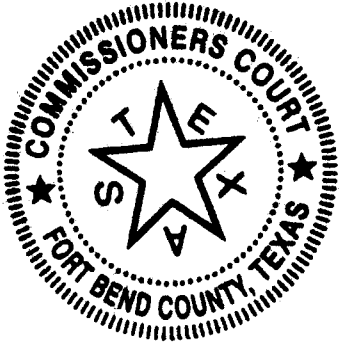

- Provide project deliverables as detailed below

## Project Resources

Datavox will assign a project coordinator and a lead project engineer who will remain in this role throughout the project. The lead project engineer will incorporate additional engineering resources in the project as needed. All personnel will have the requisite certifications and skills necessary to perform as experts to fulfill the project scope. Datavox strives to keep the same project team intact throughout the project but reserves the right to make changes to the team as necessary. Datavox will notify Fort Bend County of any changes made to the team resources.

## Project Objectives

The primary objectives of this project are as follows:

Install 1 Cisco new Catalyst Switches for the new Ft. Bend County Justice Center

## Project Plan

### Phase 1 – Pre-Installation

Phase 1 of this project will consist of the following actions and items.

- Schedule meetings with client
- Coordinate scheduling to work with Fort Bend County team

- Gather information from necessary network devices

## Phase 2 – Install New Cisco Catalyst Switches for the Justice Center

Phase 2 of this project will consist of the following actions and items.

### Network Hardware Installation

- DataVox will unpack and inspect equipment and remove all packing materials. DataVox will verify successful power-up diagnostics. Units will be observed upon power-up to determine successful completion of self-test diagnostics. DataVox will also connect all adjuncts to your communication system stated in the contract.
- DataVox will program and install one Cisco 4510RE Catalyst Chassis Switch with Dual Supervisors and Dual power supplies. DataVox will also program and install nine 4506E Catalyst Switches with dual power supplies and single supervisor.
- DataVox will implement QoS on the all 10 switches.
- Fort Bend County will provide IP address information for all VLAN's.
- Fort Bend County will provide DHCP server/scopes to be used for all VLAN's.
- Fort Bend County is responsible for any extra equipment that might be needed for connectivity.
- DataVox will assist Fort Bend County in making necessary configuration changes on existing Cisco gear in order to implement QoS.
- Fort Bend County will provide floor plans with all closets clearly identified.

Note: Customer is responsible for the provisioning and placement of any power source/s (AC and/or DC).

### Knowledge transfer:

- DataVox will provide training for System Administrators that reflects the programming of your Cisco Ethernet Switches. You will be able to perform most tasks required on a daily basis. This training will be conducted on Fort Bend County site by the DataVox engineer that performed programming. Typically this is approximately 2-4 hours.

- Coordinate, monitor and manage tasks throughout the project. Make adjustments as necessary to achieve project goals within budget and schedule

## Work Hours

Datavox has priced the professional service proposal assuming that all work will be done during normal business hours which Datavox defines as Monday – Friday, 8am – 5pm, excluding holidays. Datavox has accounted for two after hours activities which includes the system go live of the network and communication system. These project milestone activities can be scheduled outside of normal business hours Monday – Friday, excluding holidays. The start time for this activity can be scheduled to start no later than 7pm. Any request to perform the system go live or any other activity outside of normal business hours is considered outside the scope of work and will result in additional project costs. Scheduling and availability of resources outside of normal business hours is not guaranteed.

## **Non-Solicitation of Employees**

Customer agrees not to hire or otherwise solicit employment of any Datavox employee for a period of two (2) years after the date of this agreement. Customer agrees that the damages to Datavox for any breach of this section will be substantial, but difficult to ascertain. Accordingly, if Customer breaches this agreement, it shall pay to Datavox an amount equal to the annual compensation of the Datavox employee solicited or hired, which amount shall be paid as liquidated damages, as a good faith effort to estimate the fair, reasonable and actual damages to Datavox, and not as a penalty. Nothing in this agreement shall be construed to prohibit Datavox from pursuing any other available rights or remedies it may have against the employee.

## **Travel Expenses**

The customer is responsible for travel expenses incurred throughout the project. Travel expenses include airfare, accommodations, transportation and per diem. These expenses are passed from Datavox to the customer at the cost incurred.

## **Virus Protection**

Customer agrees and understands it is Customer's responsibility to install and run an antivirus program on all workstations and servers at/or prior to installation. Customer agrees to take whatever steps Customer deems appropriate to ensure there is adequate and up to date virus protection on all workstations and servers. Customer expressly agrees that Datavox, Inc shall have no liability for the loss of any such data, downtime or other damage caused by a computer virus.

## **Data Back-Up**

Customer agrees to take whatever steps Customer deems appropriate to ensure there are adequate, up to date back-ups made of databases. Datavox assumes no responsibility for retaining a system backup or ensuring that standard system back up procedures are in place or operational. FORT BEND COUNTY is responsible for maintaining its own procedures for the reconstruction of lost or altered files, backup or saving of data or programs to the extent deemed necessary by FORT BEND COUNTY and for actually reconstructing any lost or altered files, data or programs. Datavox assumes no responsibility for the protection of FORT BEND COUNTY's data. Datavox is not liable for damage to software or data caused by service to the computer hardware equipment. FORT BEND COUNTY agrees that it shall have the sole responsibility for safeguarding the software and data during service work performed by Datavox. Datavox is not liable for software damage due to any outside factor, i.e. software virus.

## **Force Majeure, Choice of Law and Venue**

Neither party shall be liable for any failure or delay in performance of its obligations hereunder where such performance is prevented or delayed by causes beyond its reasonable control,

including without limitation, flood, war, embargo, strike or other labor dispute, riot, acts of God or the intervention of any government authority. This SOW and all matters relating thereto shall be governed exclusively by the substantive law of the State of Texas and any dispute relating directly or indirectly to this SOW or any other contract or agreement between the parties shall be brought in a court of competent jurisdiction in Harris Fort Bend County, Texas, that being the exclusive venue for any dispute between or any claims held by any of the parties to this SOW.

## **Miscellaneous**

This SOW constitutes the entire agreement of the parties and supersedes all prior written or oral agreements, representations and understandings relating to the subject matter hereof. This SOW shall not be amended or modified except by written instrument signed by the parties.
