Re: Supplemental Engagement for Legislative Services

Dear Board of Directors:

Thank you for asking us to represent the Fort Bend Grand Parkway Toll Road Authority (the "Authority") in connection with the upcoming 82nd Regular Session of the Texas Legislature. As you know, we currently serve as general counsel and bond counsel to the Authority pursuant to an engagement letter between the Authority and Allen Boone Humphries Robinson LLP, as it may have been amended (the "Engagement Letter"). This letter constitutes our agreement to provide supplemental legal services to you pursuant to the terms of the Engagement Letter, as supplemented and amended hereby.

The Authority is particularly interested in legislation relating to: transportation, toll roads, the Texas Department of Transportation, special districts that may assist in the financing of toll projects (e.g. County Assistance Districts, Transportation TIRZ, and eminent domain. Our role will be to assist the Authority in monitoring legislation relating to these subjects by reviewing filed bills and amendments and tracking the progress of such bills and amendments through House and Senate committees, calendars and floor consideration. We will regularly update the members of the Board of the Directors of the Authority and Fort Bend County representatives as to the existence and progress of bills and amendments of interest. On behalf of and at the direction of the Authority, we will lobby for or against the passage or modification of bills or amendments of interest. We will coordinate our efforts with other lobbyists for Fort Bend County.

For this matter, our fee will be a flat-fee of \$32,500, inclusive of all expenses. Such fee will be invoiced to you in five (5) equal installments during the months of January through May 2011 (i.e., \$6,500 per month).
