 NOT TO SCALE

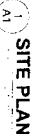
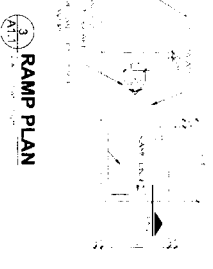
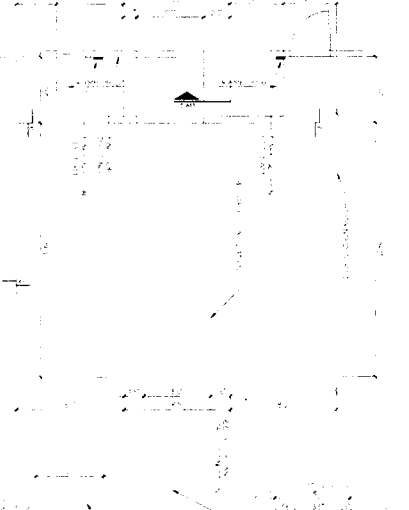
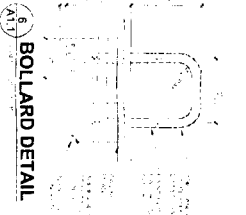
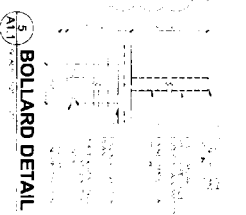
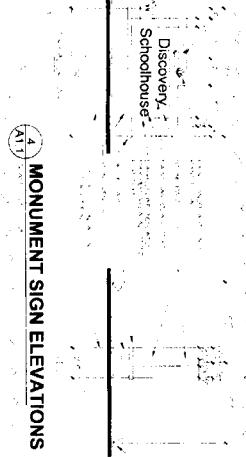

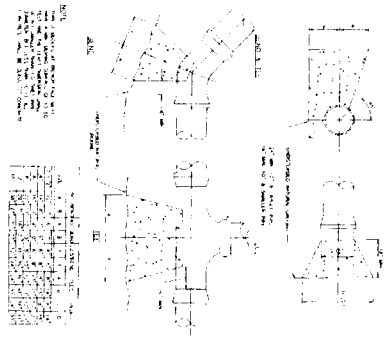
SINGLE STORY BUILDING



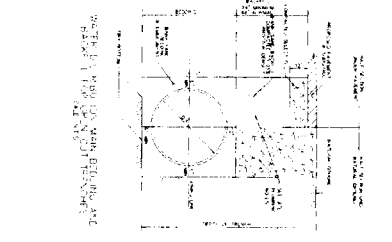

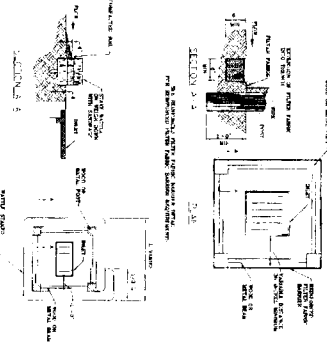
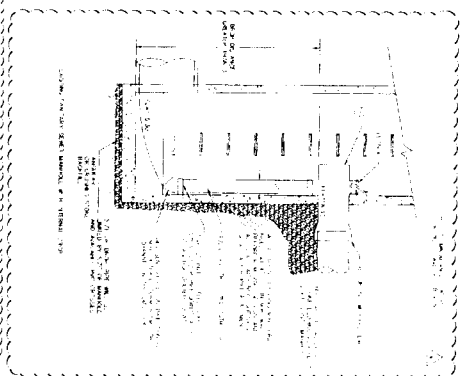
INTERIOR DETAILS FOR 2' x 8' TRIM

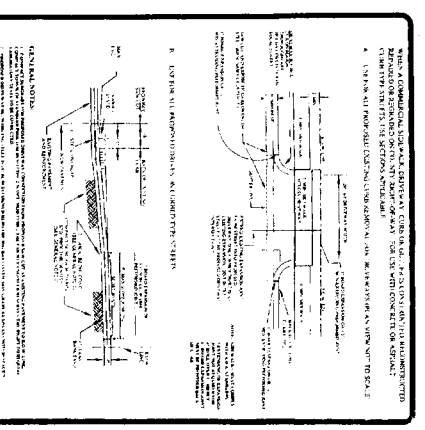
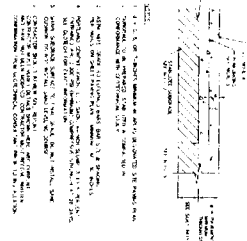
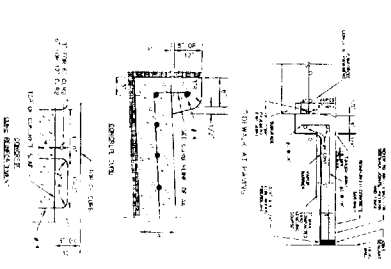
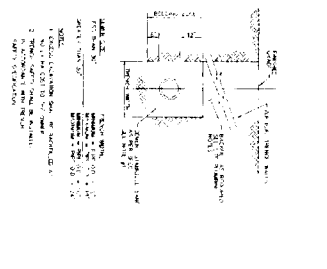


INTERIOR PROTECTION BARRIERS FOR STAGE 1 INTERIORS

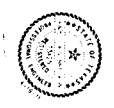
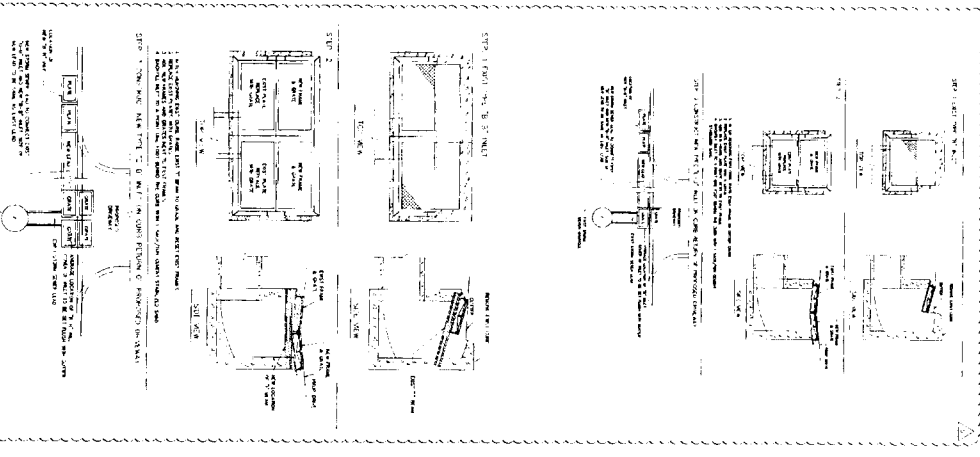
