

**AMENDMENT NO. 7 TO INTERLOCAL AGREEMENT FOR  
ADMINISTERING A LOW INCOME VEHICLE REPAIR ASSISTANCE,  
RETROFIT AND VEHICLE REPLACEMENT PROGRAM**

This Amendment is entered into between Ft. Bend County, sometimes called the "County", a body corporate and politic under the laws of the State of Texas and the Houston Galveston Area Council (H-GAC), a regional planning commission operating under Texas Local Government Code, chapter 391.

WHEREAS, The County has entered into a current TCEQ Grant Funding Agreement with the Texas Commission on Environmental Quality ("TCEQ Agreement") and

WHEREAS, on or about April 8 2003, the County and H-GAC entered into an Interlocal Agreement (the "Interlocal Agreement") providing for H-GAC to administer Low Income Vehicle Repair Assistance Program (LIRAP) funds; and

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained, H-GAC and Ft. Bend County agree to amend the Interlocal Agreement as follows:

1. Section VIII of the Interlocal Agreement, reading:

The term of this Agreement shall commence on the date last executed by the parties and continues through August 31, 2011.

is amended to read:

Subject to earlier termination as set forth above, the term of this Agreement shall commence on the date last executed by the parties and continue through a mutually agreeable period or until such time that either party requests termination.

2. Section II of the Interlocal Agreement, reading:

H-GAC agrees to administer LIRAP on behalf of County and in accordance with applicable state law, state rules and the contract between TCEQ and the County, which is attached hereto and is made a part of this agreement. H-GAC agrees that not more than five percent of LIRAP funds provided may be used for administrative costs.

is amended to read:

H-GAC agrees to administer LIRAP on behalf of Ft. Bend County and in accordance with applicable state law, state rules and the contract between TCEQ

and the County, which is attached hereto and is made a part of this agreement. The County agrees that its LIRAP funds may be used in any other LIRAP-participating county in the Houston-Galveston region. H-GAC will not use funds elsewhere in the region until all requests for funds from County residents in a given year have been met. H-GAC also agrees that not more than ten percent of LIRAP funds provided may be used for administrative costs.

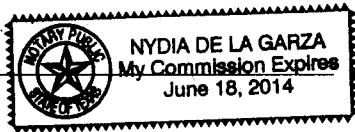
