ADDENDUM TO  
AGREEMENT FOR INGIDENT BURIAL SERVICES  
RFP 11-012

THIS ADDENDUM, entered into by and between Fort Bend County, a body corporate and politic under the laws of the State of Texas, acting herein by and through its Purchasing Agent, according to Texas Local Government Code §262.011(d), hereinafter referred to as "County," and Hernandez Funeral Home (hereinafter "CCH") authorized to conduct business in the State of Texas.

THAT, WHEREAS, the parties accepted AGREEMENT FOR INGIDENT BURIAL SERVICES RFP 11-012 executed by County on January 4, 2011 (hereinafter, "the Agreement") as attached hereto and incorporated by reference, inclusive of all attachments, exhibits and schedules; and,

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein:

1. Unless sooner terminated pursuant to the terms of this Agreement, and upon approval of funding by the Commissioners Court during the budget process relating to any Renewal Term, this Agreement shall be renewed effective October 1, 2011, for an additional one-year term, and will automatically renew each successive October 1 for up to an additional three (3) years, terminating on September 30, 2015.
2. Contractor shall secure grave space only at cemeteries located in Fort Bend County, unless County provides prior written authorization for an out of county location. Contractor's request for alternate burial sites shall be presented to County prior to the need to schedule a burial.
3. Contractor must notify County at least 48 hours prior to any burial service conducted under this Agreement.
4. All terms and conditions of the Agreement, including any addenda, not modified herein shall remain in full force and effect and for the term of this renewal. If there is a conflict between this Addendum and the AGREEMENT FOR INGIDENT BURIAL SERVICES RFP 11-012 executed by County on January 4, 2011, the provisions of this Addendum shall prevail.

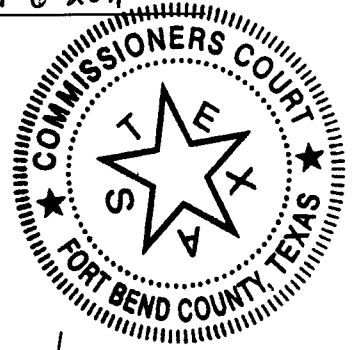
