The Transportation Policy Council (TPC) requests your appointment of a representative and a designated alternate member to serve on the TPC for 2012. Representing local governments in Brazoria, Fort Bend, Waller, Montgomery, Liberty, Chambers, Galveston and Harris Counties, the TPC is responsible for development of the region's long-range transportation plan. All transportation projects receiving funding through the Federal Highway and the Federal Transit Administrations must be approved within this plan and subsequently programmed by the TPC for funding within its four-year Transportation Improvement Program (TIP). Because of the many critical transportation policy decisions facing our region, appointment of elected officials as TPC primary voting members is strongly encouraged.

In addition to TPC voting members and alternates, you are also invited to appoint a representative and designated alternate to the Technical Advisory Committee (TAC). The TAC provides important input and review to the H-GAC staff planning activities in the development of the Regional Transportation Plan (RTP) and TIP. Staff professionals with expertise in transportation planning, engineering or related fields are recommended for this Committee.


