AND WHEREAS, the principal desires to provide Fort Bend County with a performance bond covering all such cable, conduit and/or pole line activity;

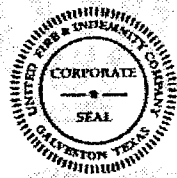
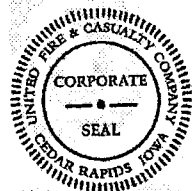
**"Article V - Surety Bonds and Undertakings"**

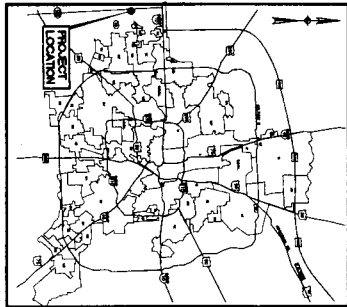

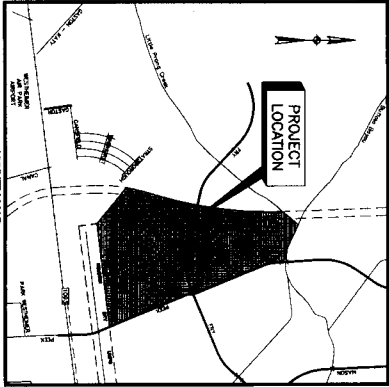
