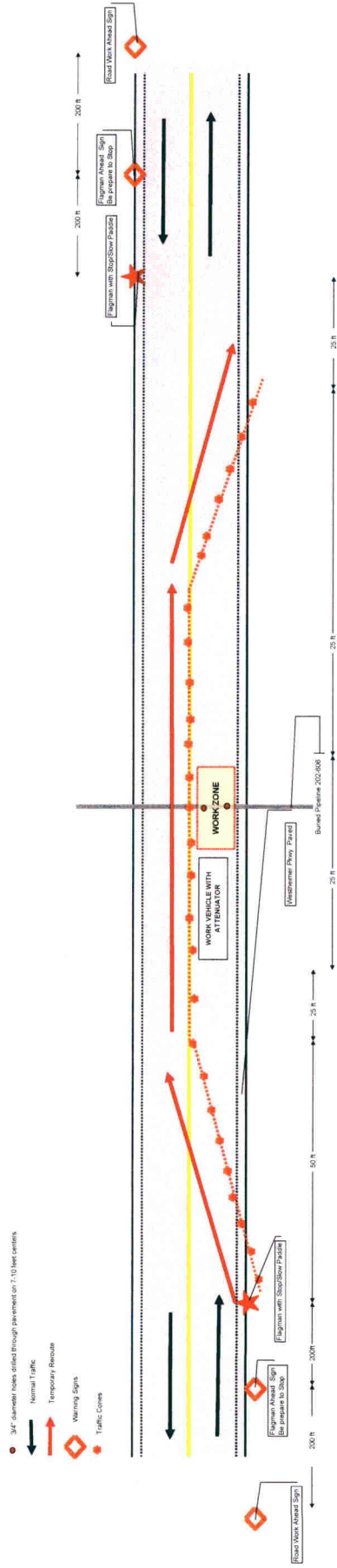


Figure 1: Working in East Bound Lane

 Between the hours of 9:00AM and 11:00AM or 1:00 PM to 3:00PM

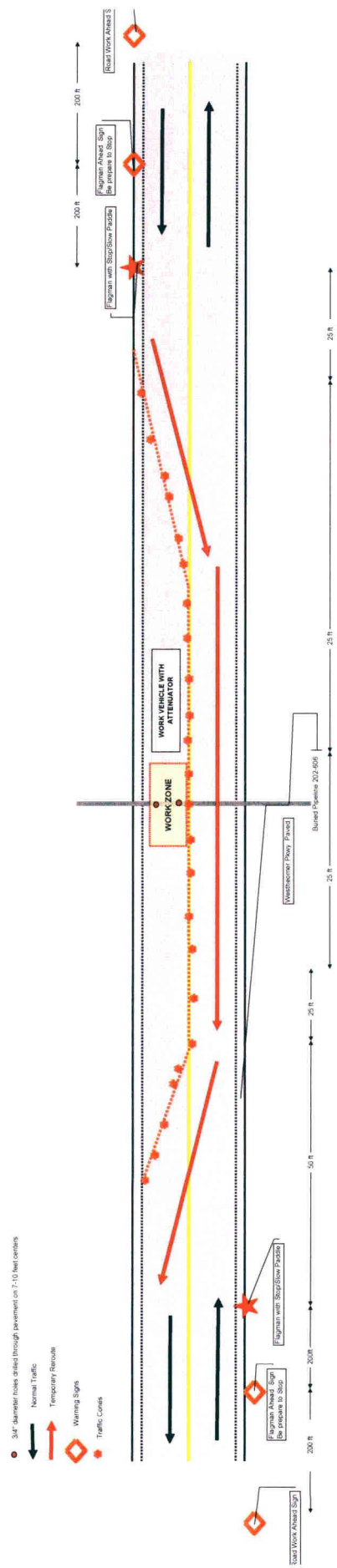


Figure 2 - Working in West Bound Lane

 Between the hours of 9:00AM and 11:00AM or 1:00 PM to 3:00PM

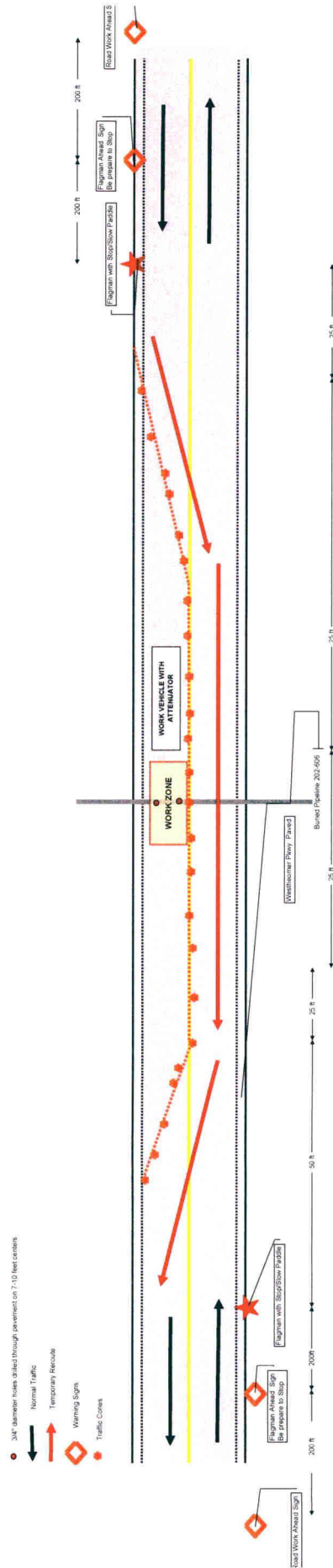


Figure 2. Working in West Bound Lane
