

RESOLUTION REQUESTING COMMISSIONERS COURT OF FORT BEND COUNTY  
TO APPOINT DIRECTORS TO FORT BEND COUNTY LEVEE IMPROVEMENT  
DISTRICT NO. 15 BOARD OF DIRECTORS

WHEREAS, the Commissioners Court of Fort Bend County, Texas, has heretofore appointed Frank Yonish, Dana Leared Koy and Allan J. Harris as directors of Fort Bend County Levee Improvement District No. 15 (the "District"), for terms that will expire on September 19, 2012; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the directors of the District and to approve the sworn statements and bonds and oaths of office for such directors; and

WHEREAS, the Board of Directors of the District hereby requests that the Commissioners Court of Fort Bend County, Texas appoint Frank Yonish, Dana Leared Koy and Allan J. Harris for new terms to expire on September 19, 2016 and approve their sworn statements and bonds and oaths of office, which are in proper form and have been properly executed; and

WHEREAS, Frank Yonish, Dana Leared Koy and Allan J. Harris are over twenty-one years of age, are resident citizens of Fort Bend County, and are otherwise qualified by law to serve as directors of the District, and are not disqualified from serving as directors of the District by reason of any law; and

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 15 THAT:

Section 1: The Board of Directors hereby requests that the Commissioners Court of Fort Bend County, Texas, appoint Frank Yonish, Dana Leared Koy and Allan J. Harris as directors on the Board for the lawful four-year term of office, which expires on September 19, 2016 and approve their sworn statements and bonds and oaths of office.

WHEREAS, the Commissioners Court of Fort Bend County, Texas, has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 15 (the "District"), and approved the bonds and oaths of such Directors; and

WHEREAS, the terms of offices of the existing directors of the District expire on September 19, 2012; and

WHEREAS, the Commissioners Court of Fort Bend County, Texas, desires to reappoint Dana Leared Koy, Frank A. Yonish, and Allan J. Harris to serve as Directors for the District for the lawful four-year term of office expiring September 19, 2016, or until their successors shall be appointed and qualified; and

WHEREAS, the sworn statements and the bonds and oaths of office of Dana Leared Koy, Frank A. Yonish, and Allan J. Harris are in proper form, have been properly executed, and are hereby approved by the County Judge and Commissioners Court of Fort Bend County, Texas; and

WHEREAS, Dana Leared Koy, Frank A. Yonish, and Allan J. Harris are over twenty-one years of age, resident citizens of the State of Texas, otherwise qualified by law to serve as Directors of the District, and not disqualified from serving as Directors of the District by reason of any law; and

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the County Judge and Commissioners Court of Fort Bend County, Texas that:


Section 1: The foregoing recitals be and the same are hereby found to be true and correct.


Section 4: A copy of the Order shall be recorded in the minutes of this Court.
