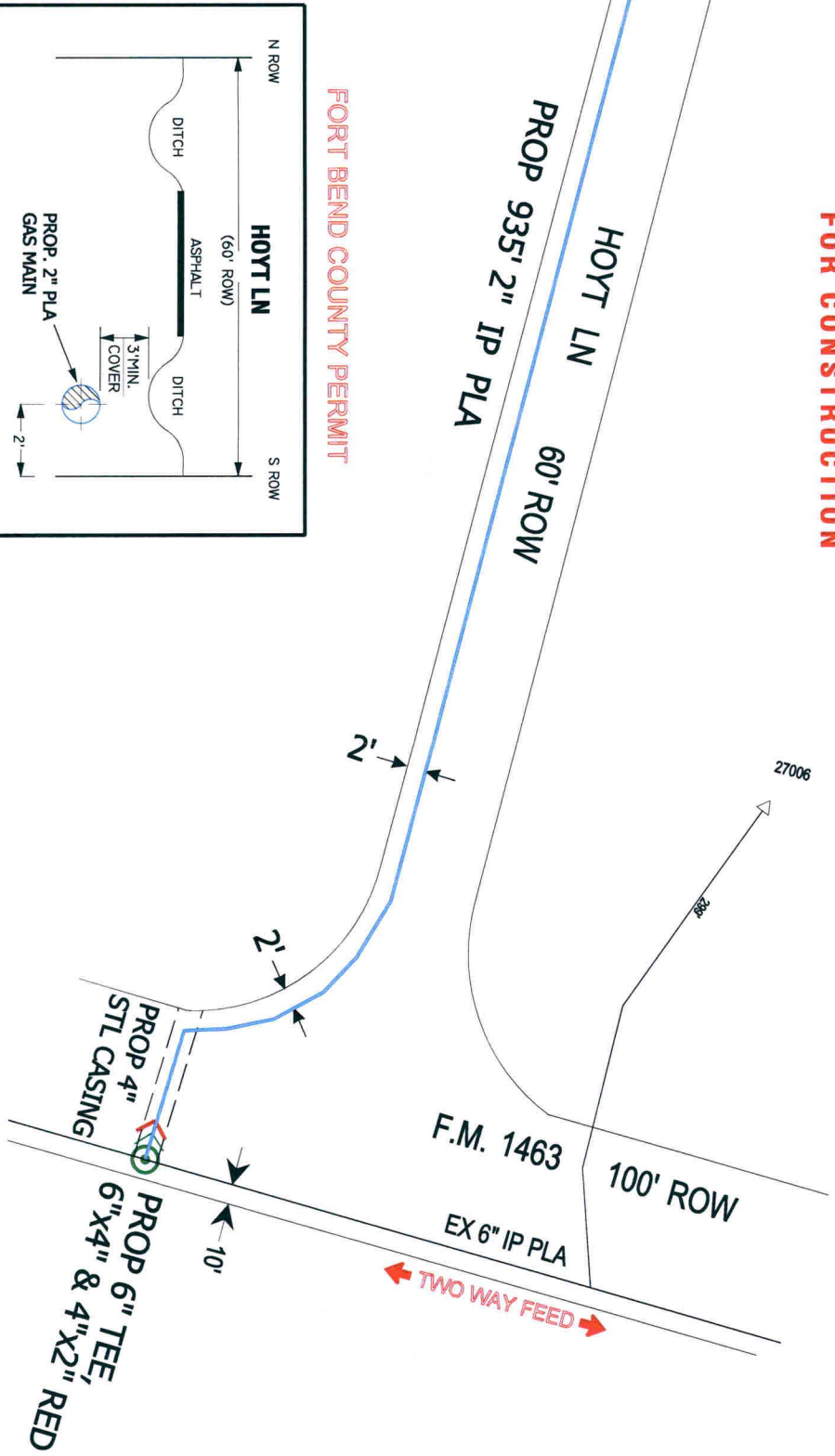

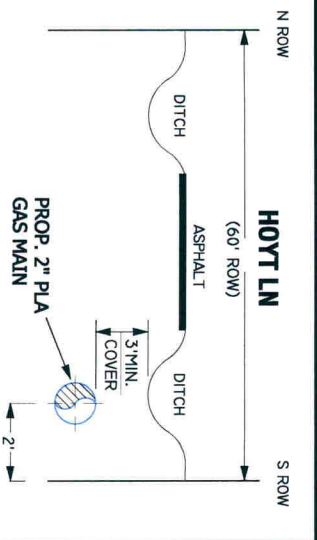

FORT BEND COUNTY PERMIT

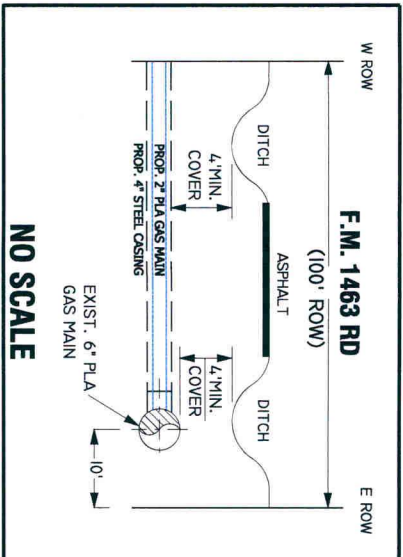
