

**AMENDMENT TO AGREEMENTS FOR THE JOINT CONSTRUCTION,  
MAINTENANCE AND OPERATION OF THE FORT BEND PARKWAY TOLL ROAD  
AND THE FORT BEND WESTPARK EXTENSION TOLL ROAD**

This Amendment is made and entered into by and between Harris County, a political subdivision of the State of Texas, and Fort Bend County, a political subdivision of the State of Texas.

WITNESSETH:

**WHEREAS**, on January 27, 2004, Harris County and Fort Bend County entered into an Agreement for the Joint Construction, Maintenance and Operation of the Fort Bend Parkway Toll Road, which was amended by the parties on June 21, 2005 (hereinafter referred to as the "Fort Bend Parkway Agreement");

**WHEREAS**, on April 26, 2005, Harris County and Fort Bend County entered into an Agreement for the Joint Construction, Maintenance and Operation of the Fort Bend Westpark Extension Toll Road (hereinafter referred to as the "Westpark Extension Agreement"); and

**WHEREAS**, the parties wish to amend the Fort Bend Parkway Agreement and the Westpark Extension Agreement to discontinue the maintenance obligations by Harris County on those roadways.

**NOW, THEREFORE**, Harris County and Fort Bend County, in consideration of the mutual covenants and agreements contained herein, do mutually agree as follows:

I.

Section 1.4 of the Fort Bend Parkway Agreement is deleted in its entirety and is replaced in its entirety with the following:

"Section 1.4. Facilities Maintenance

Harris County shall have no responsibility for roadway maintenance on the Fort Bend Parkway Toll Road."

II.

Section 1.3 of the Westpark Extension Agreement is deleted in its entirety and is replaced in its entirety with the following:

"Section 1.3. Facilities Maintenance

Harris County shall have no responsibility for roadway maintenance on the Fort Bend Westpark Extension Toll Road."

III.

Except as modified herein, the terms and conditions of the Fort Bend Parkway Agreement and the Westpark Extension Agreement remain in full force and effect.
