WHEREAS, the Commissioners Court of Fort Bend County, Texas ("Commissioners Court"), has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 11 (the "District") to serve for lawful four-year terms of office expiring June 27, 2014; and

WHEREAS, Ron McCann resigned from the Board of Directors of the District effective September 18, 2012; and

WHEREAS, the Commissioners Court desires to appoint Stuart Rimes to serve as Director for the District for the remaining term of office expiring June 27, 2014, or until his successor shall be appointed and qualified; and

WHEREAS, Stuart Rimes is over twenty-one years of age, a resident citizen of the State of Texas, is otherwise qualified by law to serve as a Director of the District, and is not disqualified from serving as a Director of the District by reason of any law; and




