THIS AGREEMENT is made and entered into by and between the Fort Bend County, a body corporate and politic under the laws of the State of Texas, acting by and through the Fort Bend County Commissioners Court, hereinafter referred to as "County," and Fort Bend Regional Council on Substance Abuse, Inc. (FBRC), hereinafter referred to as "Contractor," authorized to conduct business in the State of Texas.

WITNESSETH:

WHEREAS, County desires that Contractor implement and maintain Tobacco Prevention and Control Direct Services in the community, as detailed in Contractor's response to RFP 08-052, hereinafter referred to as the "Project," for the purpose of reducing the use of tobacco products and reducing exposure to second hand smoke within Fort Bend County; and

WHEREAS, Contractor represents that it is qualified and desires to perform such services;

NOW, THEREFORE, County and Contractor, in consideration of the mutual covenants and agreements herein contained, do mutually agree as follows:

SECTION 1 SCOPE OF AGREEMENT

The Contractor agrees to perform professional and experienced tobacco prevention and cessation activities, in coordination with the Tobacco Free Fort Bend Coalition and in connection with the Project as stated herein and for having rendered such services, the County agrees to pay to the Contractor compensation as stated herein.

SECTION II CHARACTER AND EXTENT OF SERVICES

- Contractor shall provide the services detailed in Attachment A, February 28, 2008 2.01 proposal from Contractor, attached hereto and incorporated by reference as if set forth herein verbatim.
- Contractor agrees to complete the services called for in Attachment A between the date 2.02 of this agreement and August 31, 2008.

SECTION III CONTRACTOR'S COMPENSATION

For and in consideration of the services rendered by the Contractor, and subject to the 3.01 limit of appropriation under Section VII, County shall pay to the Contractor an amount not to exceed \$57,548.00, including any expenses.

- 3.02 Contractor shall submit invoices to County and County shall pay each invoice within thirty (30) days after the County Project Manager's written approval provided however, that the approval or payment of any invoice shall not be considered to be conclusive evidence of performance by the Contractor to the point indicated by such invoice or of receipt or acceptance by the County of the services covered by such invoice.
- 3.03 Contractor's fees shall be calculated at rates not to exceed the amounts included on Attachment A, incorporated by reference herein as if set-forth verbatim.

SECTION IV TERMINATION

- 4.01 County may terminate this Agreement at any time by providing ten (10) days written notice to Contractor.
- 4.02 Upon receipt of such notice, Contractor shall discontinue all services in connection with the performance of this Agreement and shall proceed to cancel promptly all existing orders and contracts insofar as such orders or contracts are chargeable to this Agreement.

- 4.05 Copies of all completed or partially completed electronic data files and specifications prepared under this Agreement shall be delivered to the County when and if this Agreement is terminated in the manner and for the purposes provided in this Agreement.

SECTION V PROFESSIONAL LIABILITY INSURANCE

Contractor shall, prior to performing billable services and for the duration of term of this Agreement, keep in full force and effect a policy of professional liability insurance of not less than \$1,000,000.00 for each claim aggregate, which shall be approved by the Fort Bend County Risk Management Department prior to purchase. The policy shall contain a clause that the insurer will not cancel or reduce the insurance without first giving County ten (10) days prior written notice. Prior to the execution of this Agreement, Contractor has been advised by County, and Contractor clearly understands and agrees, such understanding and agreement being of the absolute essence to this contract, that County shall have available the total maximum sum of \$57,548.00, including reimbursable expenses, if any, specifically allocated to fully discharge any and all liabilities which may be incurred by County.

7.02 Contractor does further understand and agree, said understanding and agreement also being of the absolute essence of this contract, that the total maximum compensation that Contractor may become entitled to hereunder and the total maximum sum that County shall become liable to pay to Contractor hereunder shall not under any conditions, circumstances or interpretations thereof exceed the sum of \$57,548.00 for described

scope of work in Attachment A.

Contractor does further understand and agree, said understanding and agreement also being of the absolute essence of this contract, that the Contractor will contribute an inkind match of \$2,877 or five percent (5%) of the payment received from the County from unreimbursed indirect costs expended in support of this Project. Contractor shall provide documentation of the in-kind match expenses to the County at the close of the project period.

Any oral or written representations or modifications concerning this instrument shall be of no force and effect excepting a subsequent written modification signed by both parties hereto.

- 14.01 By entering into this Agreement, the parties do not intend to create any obligations, express or implied, other than those specifically set out in this Agreement.

to benefit its client; Contractor and other parties should not rely on this approval and should seek review and approval by their own respective legal counsel.

14.04 If there is a conflict between this Agreement and Attachment A, the provisions of this Agreement shall prevail.

ATTACHMENT "A"

The Fort Bend Regional Council on Substance Abuse, Inc. (FBRC) requests \$57,548.00 to provide the Direct Service functions of the Tobacco Prevention and Control Coalition Program.

FBRC is the most qualified applicant to provide the services because the agency is a key member of the "Tobacco Free Fort Bend Coalition" and has been the recipient of DSHS funding to provide the precise services requested in this proposal for over five years. FBRC only ceased providing these services in December, 2007 because the agency type became ineligible to apply for continued funding. A subcontractor relationship with Fort Bend County HHS will allow FBRC to continue direct services to the community without significant interruption. FBRC's experience and qualifications are detailed below.

Fort Bend Regional Council on Substance Abuse, Inc has the following mission statement: Providing families and individuals substance abuse prevention, education, and treatment services they need for positive change for themselves and the community.

<u>Purpose</u>: In 1976, The Fort Bend Regional Council on Alcohol and Drug Abuse (FBRC) opened its doors to serve the alcohol and drug abuse related needs of families throughout Fort Bend County. For over 30 years, the Council's philosophy strongly emphasizes productive partnerships with residents, schools, civic organizations, churches and businesses countywide. Over the years, the Council has expanded its scope of services to address the emergent needs of the community and provide more comprehensive services to our clients.

FBRC has coordinated and provided tobacco prevention and cessation services since 2001, initially through the "Tobacco Interagency Program" (TDHHS) provided services in Fort Bend County. In 2003 program was invited to expand into southwest Harris County. This expansion was merit based. Present DSHS funding in the amount of 120,000 annually allows two full time Cessation Specialists to increase the agency's reach each year. In FY2006, FBRC impacted over 16,000 individuals in Fort Bend and Harris Counties. Active collaboration and a leadership role in the Tobacco Free Fort Bend coalition provided FBRC with the opportunity to be a key participant in achieving environmental policy amendments. The Cessation Specialists assisted the coalition in passing a smoke-free ordinance in Sugar Land, Texas (2006). FBRC staff supported the Breathe-free Houston initiative to pass a similar ordinance in the City of Houston.

FBRC is one of only a select few DSHS funded treatment facilities within the county. The Adult Outpatient Treatment Programs provide comprehensive care to individuals suffering from alcohol and other drug abuse problems. These programs provide intensive tobacco cessation education from the addiction perspective. This is a successful cessation intervention for individuals who are focused on recovery from affiliated addictions.

Role and Experience in Tobacco Control Activities

FBRC initially received Tobacco Interagency Program funding through the Texas Department of Health in 2001. This provides FBRC with two full time Tobacco Cessation Specialists (TCS) who have successfully reduced tobacco use throughout Fort Bend County. FBRC employs creative methods to promote the ACS (ACS) Quit Line a free, statewide tele-counseling service, including consultation with health care providers to encourage their patients to stop using tobacco products through education of the Clinical Practice Guidelines for Treating Tobacco Use and Dependence. Utilizing the 5-A's (ask, assist, advise, arrange, and assess) model. The TCS

discusses the Yes You Can Tool Kit with health care professionals and assists them in integrating it into their practice.

The TCS has successfully counseled managers in the workplace about the Quit Line service. Managers learn about the free service and encourage their employees to stop using tobacco products. Quit line cards are placed in employee orientation packages at several local companies. The TCS is present at employee health fairs to distribute information and promote the quit line.

Program Impact & Success

Health Care Providers - In May of 2002, the TCS planned a special event to honor 55 Fort Bend ISD school nurses during Nurses Week. Successful collaboration with the Nurses Oncology Education Program (NOEP) in Austin, Texas provided free CEUs for the nurses in attendance. Dr. Joel Dunnington, Radiologist at M. D. Anderson Cancer Center served as keynote speaker for the event. Dr. Dunnington spoke about the deceptive advertising tactics of the tobacco industry and how they lure children to begin smoking. The TCS educated the nurses about the ACS Quit Line's new availability to teenagers. University of Texas School of Public Health Research students surveyed the nurses regarding tobacco use. The event's goal was to encourage nurses to refer youth and their parents to the ACS Quit Line to increase attempts and cessation among residents of Fort Bend County.

In October, 2002 the TCS conducted two events for nurses at Memorial Hermann Hospital in Missouri City, Texas. The objective was to recognize October as Breast Health Awareness month and addressed tobacco use as a cause of breast cancer. Successful collaboration with U.S. Oncology Corporation provided lunch and snacks, and two speakers for the event: Dr. Blossom Zanger and Dr. William Velasquez who spoke about breast cancer. Dr. Joel Dunnington, Radiologist at M.D. Anderson Cancer Center spoke about tobacco. This event offered free nursing CEUs through collaboration with NOEP. Nurses were educated about the ACS Quit Line to encourage them to refer their patients to the quit line service thereby increasing patient's quit attempts.

In June of 2003 the TCS held two nurses events using the same method described above. The events took place at Oak Bend Hospital in Richmond, Texas and Mcmorial Hermann Hospital in Missouri City, Texas. FBRC provided funding for Dr. Victor DeNoble, tobacco industry whistle blower, to tell his story regarding his work at Philip Morris, and discuss pharmacological research on nicotine addiction. NOEP offered free CEU credits and U.S. Oncology donated lunch. The TCS discussed the ACS Quit Line to encourage health care providers to refer their patients. The purpose was to increase the number of health care providers who screen each patient for tobacco use and increase the number of youth and adults who seek cessation assistance.

The TCS has successfully consulted with area health care providers to educate them about the ACS Quit Line. Information is communicated to the health care providers to determine their readiness to incorporate the Yes You Can Tool Kit into their practice. The Clinical Practice Guidelines for Treating Tobacco Use and Dependence, 5-A's (advise, assist, arrange, ask, and assess) informs the provider how to counsel their patients in order for the patient to succeed during their quit attempts. It is important for health care providers to realize the quit line service is available for their young patients between the ages of 13 through 18, as well as adult patients. The consultant identified several practices that agreed to utilize the tool kits in Fort Bend County

including OB/GYN's, pediatricians, chiropractors, dentists, and family physicians, and emphasized the services availability for teenagers.

The TCS provided specialized priority outreach services for a population of cancer patients at an Oncologist's Office in Richmond, Texas, the Sugar Land Cancer Center, and U.S. Oncology in Sugar Land, Texas. An alliance with Dr. Vroulis from Sugar Land Cancer Center resulted in a public education presentation discussing successful cessation tips during January of 2004.

The TCS has participated in the Fort Bend Business Expo for the past four years. This has opened doors to building new relationships with business leaders and health care providers who are interested in assisting employees and patients with their quit attempts.

Media - The TCS Cessation Consultant has been active in coordinating creative media messages regarding the ACS Quit Line and the Yes You Can Campaign throughout Fort Bend County with the assistance of the Texas Department of Health Office of Tobacco Prevention in Austin, Texas. Locally, on-screen advertisements were used at two different movie mega-plex theaters in Fort Bend County to reach a diverse audience of youth and adults. The message was displayed on movie screens at each facility before the feature presentation began. The message was also shown at the front of the movie theater in Sugar Land on a 5' x 8' cine-sign. The message was initially displayed during July of 2003, and was on display as a PSA by the movie theater as of January 2007. Community reminders increase the number of youth and adults who seek cessation assistance, and ultimately, reduce the number of tobacco users in Fort Bend County.

Advertisements regarding the quit line service were displayed on grocery carts at several grocery stores throughout Fort Bend County through a national marketing service. The TCS took advantage of in-store radio messaging to promote the quit line service at the same grocery stores that used the grocery cart-advertising program and several drug stores in order to reach a vast audience of listeners. The same message used on the grocery carts was printed in several local newspapers to serve as a reminder about the quit line service before each grant year ended. During 2003 the same message was used by the national marketing service in the May 15, Sunday coupon section of the Houston Chronicle. The Sunday circulation numbers in the Fort Bend and Greater Houston area were approximately 785,000.

Outreach - The TCS performed outreach activities to reach the diverse population of Fort Bend County. During the summer the TCS organizes tobacco education activities at the county health department to reach the predominantly Hispanic population at the Rosenberg facility. These activities take place while parents and children wait to receive their immunizations to return to school. Props are used as visual aids to show the children what will happen to their bodies if they use tobacco products

The TCS conducted outreach activities at local schools, churches, youth agencies, health fairs, employer groups, and health centers throughout Fort Bend County to educate the community about the dangers of using tobacco products and the affects of second hand smoke. Information was distributed to inform community members about the ACS Quit Line.

Coalition Activities - The TCS has been active in the local tobacco coalition by serving as Chair and Co-Chair over the past five years. The TCS coordinated coalition members and representatives from three school districts to encourage student participation in an anti-smoking, placemat contest during the Great American Smoke Out. The team reviewed the placemats and 12 winners were selected. The winning drawings were used to become a calendar, which was

distributed throughout the county to promote tobacco cessation. It was provided to local businesses, health clinics, hospitals, libraries, physician's offices, and restaurants.

Education - The TCS has been effectively educated clients at Fort Regional Council on Substance Abuse, Inc. regarding the dangers of tobacco use and the effects of second hand smoke by conducting monthly presentations. This diverse group is comprised of young adults primarily between the ages of 18 and 24 years old who are involved in a recovery program for alcohol and/or drug abuse. Many of them use tobacco products, and many of them are male of Hispanic, Caucasian, and African American origin. These educational presentations increase the clients' success at their quit attempts.

Further educational efforts presented information to attendees at the Society for Dental Hygienists in 2006. The hygienists learned about the 5 A's and why it is important to counsel their patients about quitting tobacco. They learned about free counseling the ACS provides through their quit line service in order to increase their patient's quit attempts. This extensive experience identifies FBRC as the most qualified to provide community based tobacco prevention and control activities following the model of the Substance Abuse Mental Health Services Administrations, Strategic Prevention Framework.

FBRC will provide a qualified and experienced Tobacco Cessation Specialist, Ms. O'Neak Henigan, MA to coordinate and deliver the services to the community. FBRC shall provide:

To achieve the goal of developing capacity to effect change in Fort Bend County FBRC will, work with "Tobacco Free Fort Bend" to use the findings of the needs assessment to guide selection and implementation of comprehensive tobacco prevention and control strategies. The Fort Bend Regional Council on Substance Abuse, Inc. proposes to deliver direct services as indicated:

Alternative Activities for Youth and Adults - these include school and community based prevention activities, participation in the Great American Smoke Out and Kick Butts Day, Tobacco Summit representation, Teen Ambassador projects, puppet shows and other activities designed to address tobacco cessation and prevention.

Community Consultations - this strategy includes meeting with health care and employers to enhance the availability of cessation resources. Healthcare consultations introduce physicians, dentists and pharmacists to the HHS Clinical Practice Guidelines for treating tobacco use, the American Cancer Society Quitline and the Yes You Can clinical tool kit. In 2006, FBRC's Tobacco Cessation Program reached over 200 healthcare providers through consultations.

Media Awareness Activities-including PSA's, print media, movie theatre screen advertising and local media coverage of Tobacco prevention activities.

Community based agreements- FBRC has held a leadership role in the Tobacco Free Fort Bend Coalition and has effectively mobilized the support of the partners indicated in this proposal and beyond.
