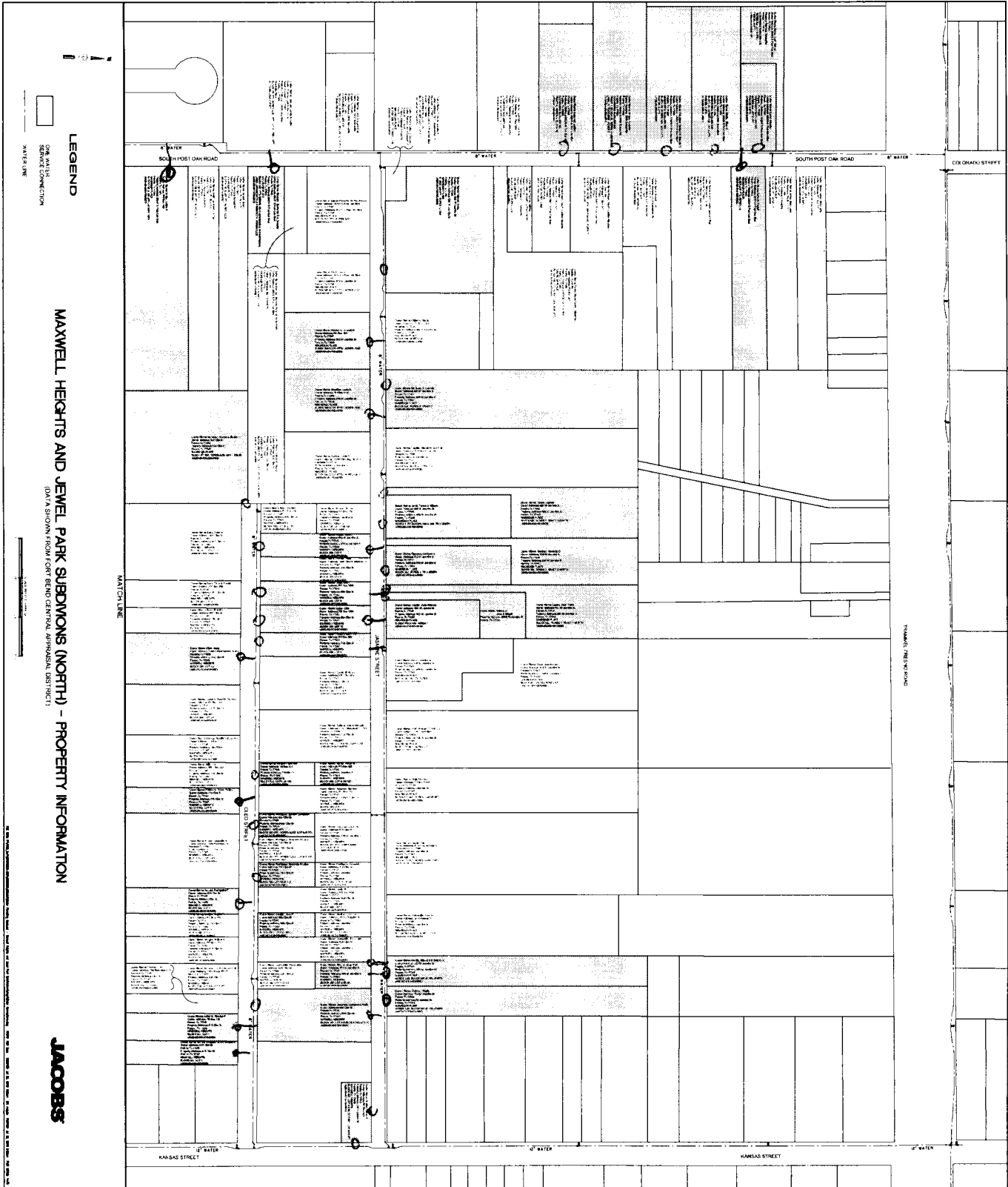

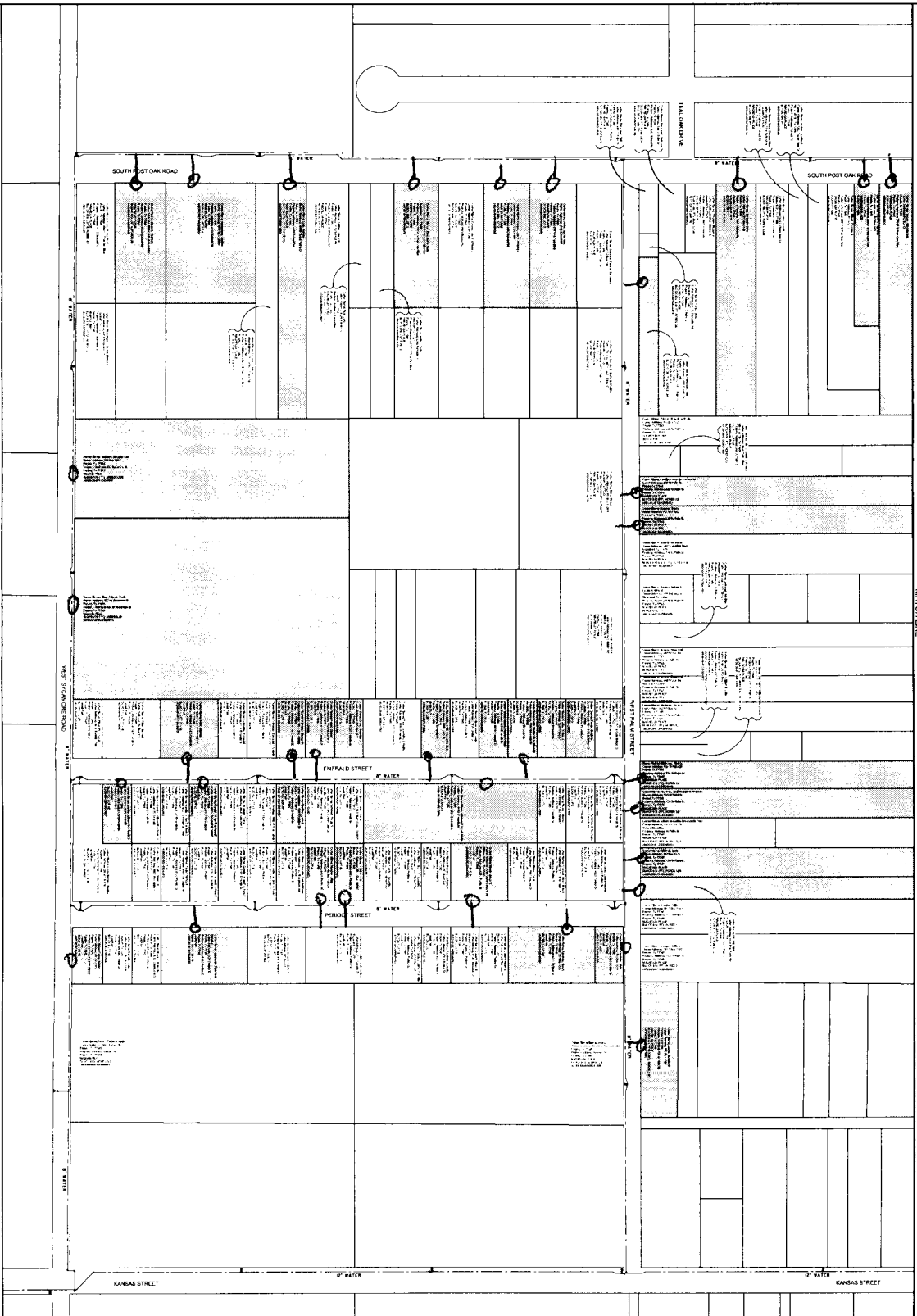

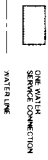
34" - 1" WATER SERVICE LINES
