**ORDER CALLING AN ELECTION TO CONFIRM THE CREATION OF FORT BEND  
COUNTY EMERGENCY SERVICES DISTRICT. 6, AND  
AUTHORIZE THE IMPOSITION OF A TAX NOT TO EXCEED THE RATE  
ALLOWED BY SECTION 48-E, ARTICLE III, TEXAS CONSTITUTION**

**WHEREAS**, the Fort Bend County Commissioners Court received PETITION FOR AN EMERGENCY SERVICES DISTRICT SEEKING TO CREATE FORT BEND COUNTY EMERGENCY SERVICES DISTRICT 6, [the "Petition"];

**WHEREAS**, the Fort Bend County Commissioners Court made the requisite findings to grant the Petition as authorized by Texas Health and Safety Code Sec. 775.017; and

**WHEREAS**, the Fort Bend County Commissioners Court granted the Petition by executing the RESOLUTION APPROVING PETITION FOR AN EMERGENCY SERVICES DISTRICT SEEKING TO CREATE FORT BEND COUNTY EMERGENCY SERVICES DISTRICT 6, IN PRECINCT 1,

IT IS THEREFORE **ORDERED, ADJUDGED, AND DECREED** BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS that:

1. An election will be held to confirm the creation of EMERGENCY SERVICES DISTRICT. 6, IN PRECINCT 1 and authorize the imposition of a tax authorized by Texas Health and Safety Code Sec. 775.018;
2. The election shall be on the 11th day of May, 2013, which date is the next available uniform election date under Chapter 41, Texas Election Code;
3. The creation of the District at the election shall be by majority vote of all the voters; except that the District shall exclude a territory in a municipality's limits or extraterritorial jurisdiction unless a majority of the voters residing in that territory who vote at the election vote in favor of creating the District;
4. The creation of the District would fail if all of the referenced municipal corporate boundaries and/or the extraterritorial jurisdictions are excluded from the District;
5. At the election, the below proposition shall be submitted to the qualified voters who reside in the proposed District:

**PROPOSITION**

**CONFIRMATION OF THE CREATION OF FORT BEND  
COUNTY EMERGENCY SERVICES DISTRICT NO. 6  
AND THE LEVY BY SAID DISTRICT OF A TAX NOT  
TO EXCEED TEN (10) CENTS ON THE ONE HUNDRED  
DOLLAR (\$100.00) VALUATION.**

6. The ballot of the election shall conform to the requirements of the Texas Election Code, as amended, and shall have printed thereon the following:

7. The Court shall enter any such further Orders in furtherance of the Election called as it shall deem necessary and proper and as required under the Texas Election Code and Chapter 775 of the Health & Safety Code, including, but not limited to the establishment of voting and election precincts, designation of Presiding and alternate Presiding Judges, the polling place locations, early voting clerk and early voting locations, the early voting ballot board and the posting and publication of the Election Notice.

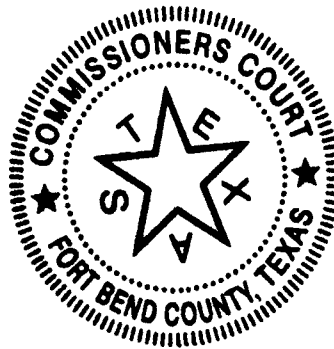
