Naveen Thomas, on behalf of Thomas, Kaithamattathil & Alice, is requesting waiver of penalty and interest for 2011 tax year, stating owners did not receive a statement.

Tax Office Records Indicate:

- June 24, 2011 Original deed #2011060259 recorded owner Kaithamattathil Thomas and Alice Thomas, with no mailing address on file.
- 2011 Original Statement, Reminder Notice and 33.07 Notice were not mailed due to no address on file.
- According to Fort Bend Central Appraisal District records, no address change was submitted to their office prior to December 28, 2012.
- There is no evidence of an error by the Fort Bend Central Appraisal District or Fort Bend County Tax Office.
- Fort Bend ISD, City of Missouri City and Houston Community College-Missouri City have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.

I <u>do not</u> recommend waiver of penalty, interest and collection fees for **2011** tax year. Property Tax Code Section 33.011 (a) (1). "The governing body of a taxing unit: shall waive penalties and may provide for the waiver of interest on a delinquent tax if an act or omission of an officer, employee, or agent of the taxing unit or the appraisal district in which the taxing unit participates caused or resulted in the taxpayer's failure to pay the tax before delinquency..."

Request for Waiver of Penalty

I, Naveen Thomas, son of Thomas & Alice Kaithamattathil requesting waiver of penalty for the year of 2011 tax on behalf of my parents, due to their English language deficiency. We haven't received the tax papers from the Fort Bend County Tax Assessor, because our mailing address was not on file. Due to my parents' language deficiency, they misunderstood from the title company during the closing time of the property that "there are no taxes due in 2011". This is the reason why they waited until the end of 2012, but they never received tax papers till now. I was told by my parents to look into the matter on 12/27/2012. We printed the statement from Fort Bend County Tax Office website, and saw that there was a pending penalty plus tax amount for the year of 2011 and only tax amounts for the year of 2012. Thomas and Naveen visited both tax offices and appraisal district on 12/28/12 to inquire about why we never received tax documents. I was told by the officials at the tax office that our title company hasn't sent in our mailing address and therefore to request the waiver of penalty. We have paid the full amount of \$4,610.17 on 12/28/12. Thomas, Alice, and Naveen fully understood that we were responsible to pay taxes, and if we haven't received the tax papers, then it is our responsibility to inquire about it. As soon as we found out that we owe the money, we paid in full amount. Misunderstandings on my parent's end resulted in not paying taxes for the year of 2011. Therefore we kindly are requesting the waiver of penalty for the year of 2011 taxes.
